## Aadhaar Letter as Proof of Address for Know Your Client (KYC) norms

SEBI vide Circular No. CIR/MIRSD/ 09 /2012 dated August 13, 2012 has informed that Aadhaar Letter can now be accepted as Proof of Address for satisfying the Know Your Client (KYC) norms. SEBI in consultation with Unique Identification Authority of India (UIDAI), Government of India, has decided that the Aadhaar Letter issued by UIDAI shall be admissible as Proof of Address in addition to its presently being recognized as Proof of Identity.

## Activation of ISIN in case of additional issue of shares/ securities

SEBI vide Circular No. CIR/MRD/DP/ 21 /2012 dated August 2, 2012 has informed that in case of IPO for debt securities, ISINs shall be activated only on the date of commencement of trading on the stock exchange. ### Know more about PAN (Permanent Account Number) Card

**1. How to apply for a PAN card?**

**Ans.** An individual can apply for a new PAN card or request for changes or correction in PAN data or request for reprint of PAN card (for an existing PAN) by downloading the application form from NSDL TIN website [www.tin-nsdl.com](http://www.tin-nsdl.com) or from Income Tax Department's website [www.incometaxindia.gov.in](http://www.incometaxindia.gov.in) or obtain the application form from nearest TIN Facilitation centre and submit the application form to the nearest TIN FC (List of TIN FCs available on aforementioned NSDL TIN website).

**2. What are the processing fees for issuing PAN card?**

**Ans.** The Processing fees for issuing PAN card are as follows:

- ₹ 96/- if dispatch of PAN card is in India.
- ₹ 962/- if dispatch of PAN card is outside India.

**(Both the above charges are inclusive of service tax)**
