Facility for holding mutual fund units in dematerialised form

SEBI vide its Circular No. SEBI/IMD/CIR No.11/183204/2009 dated November 13, 2009 has informed that for transacting in mutual funds through stock exchange platform, NSDL has enabled holding of mutual fund units in dematerialised form. In order to encourage investors to avail this facility, no fee will be levied to Participants till March 31, 2010 in respect of mutual fund units routed through the stock exchange platform.

and the same is posted on NSDL website www.nsdl.co.in.
