Redemption or Repurchase

Clients can redeem mutual fund units held in demat accounts through two modes i.e., through their Participants or Stock Brokers. To redeem the mutual fund units through Participants, Clients are required to submit Repurchase / Redemption Form (RF) to Participants. The current procedure requires the Participants to execute electronic redemption request in the eDPM System and forward the physical copy of the RF to the Issuer / Registrar and Transfer Agent (RTA). In this regard, the redemption process has been simplified as follows:

- (i) As per SEBI's advice, Participants need not forward the physical copy of the RF to the Issuer / RTA. After due verification, the RF submitted by Clients will be retained by the Participants. Participants are required to only execute electronic redemption request in the eDPM System.
- (ii) The RF has been re-designed to make it simpler for Clients and Participants to fill and process the RF respectively.

Accordingly, necessary amendments have been carried out in Business Rules.

SEBI's Clarification on opening of account in case of HUF

SEBI vide Master Circular no. CIR/MRD/DP/41/2010 dated December 31, 2010 for Depositories has clarified the following in case of Beneficial Owner (BO) account:

- **HUF, Association of Persons (AoP), Partnership Firm, Unregistered Trust, Registered Trust, Corporate Bodies, minors, etc.**

The BO account shall be in the name of natural persons, PAN card details of the respective HUF, AoP, Partnership Firm, Unregistered Trust, etc shall be obtained. The PAN number of Registered Trust, Corporate Bodies and minors shall be obtained when accounts are opened in their respective names.”

- **Opening of demat account in case of HUF**

It is noted that as per law, in case of HUF, shares can be held in the name of Existing Karta on behalf of HUF. Therefore, HUF demat accounts can be opened in the name of Existing Karta but not in the name of Deceased Karta and HUF entity.”

Accordingly, for an HUF, the accounts have to be opened under the type “HUF” in the name of Karta (i.e. natural person) who is alive and not in the name of HUF entity.

Avail free SMS Alert Facility on Your Mobile Phone

(continued from January 2011 issue)

4. What are the charges for availing this facility?

Ans: No charge is levied by NSDL on DPs for providing this facility to investors.

5. If I have already provided my mobile number to my DP at the time of opening demat account, do I still need to register for this facility?

Ans: If you have given specific request either at the time of opening your demat account or subsequently to your DP, only then your DP would be able to register you for this facility. Merely giving mobile number is not sufficient.

6. What if I have already registered with DP for this facility and still not receiving SMS Alerts on my mobile?

Ans: In this case, you can contact your DP and seek a confirmation that it has enabled your mobile number in its depository system for this facility. Even after receiving confirmation, you do not get SMS Alerts, you may contact NSDL.

7. What shall I do if I change my mobile number or if I do not want to receive SMS Alerts?

Ans: In case you change your mobile number, you will have to make a request to your DP for effecting change of your mobile number. You will then receive a message both, at your old as well as new mobile numbers in this regard. In case you do not wish to receive SMS Alerts, you have to make a request in this regard to your DP.

8. Is it mandatory for me to register for SMS Alert facility?

Ans: No, However, it is mandatory for individual accountholders whose accounts are operated through Power of Attorney (POA).

9. Where can I find more details about SMS Alert facility?

Ans: Details about SMS Alert facility alongwith terms and conditions are available on NSDL website www.nsdl.co.in. Alternately, you can contact your DP to know more about this facility.
