Revision in framework for Qualified Foreign Investor (QFI) investment in Equity Shares and Mutual Fund schemes

SEBI (Circular nos. Cir/IMD/DF/14/2011 dated August 09, 2011, Cir/IMD/FII&C/3/2012 dated January 13, 2012 and CIR/IMD/FII&C/4/2012 dated January 25, 2012) on review and in consultation with the Government of India (GoI) and RBI has revised the framework of QFI investing in Equity Shares and Mutual Fund schemes as under:

QFI shall mean a person who is;

- Resident in a country that is a member of Financial Action Task Force (FATF) or a member of a group which is a member of FATF; and
- Resident in a country that is a signatory to IOSCO's MMOU (Appendix A Signatories) or a signatory of a bilateral MOU with SEBI.

Know more about PAN (Permanent Account Number) Card

1. What is a PAN Card?

Ans. A PAN card or “Permanent Account Number Card” can rightly be called one of the most important document required for any financial transaction. PAN Card is a photo Identity card that carries 10 digits alphanumeric Unique Number for every card holder. The card is issued by the Income Tax Department (Government of India) and is allotted for the purpose of identification purposes and record.

2. Who must have a PAN?

Ans. ➤ All existing assesses or taxpayers or persons who are required to furnish a return of income, even on behalf of others, must obtain PAN.

➤ Any person, who intends to enter into economic or financial transactions where quoting PAN is mandatory, must also obtain PAN.

➤ The Assessing Officer may allot PAN to any person either on his own or on a specific request from such person.

3. Is there any age limit to apply for a PAN Card?

Ans. There is no age limit to apply for a PAN Card. In case of a minor he or she should be represented through a Representative Assesse. The minor should be represented by his/her parent or natural guardian.
