SPICE enhancement - Ascertain status of uploaded instructions and Clients registered for SPICE

NSDL has enhanced its facility called **SPICE** (*Submission of Power of attorney based Instructions for Clients Electronically*) for Clearing Members to submit instructions (*auto pay-in*) through **SPEED-e** facility with two additional features:

- (i) 'Auto Pay-in Instructions Status Download' to ascertain the status of the instructions (*auto pay-in*) uploaded through **SPEED-e** facility. With this new feature, the Clearing Member can view the status of instructions uploaded by him for its clients and will help on conveniently monitoring the pay-in obligations.
- (ii) 'POA Client List Download' to ascertain the Clients registered for **SPICE**.

Further details about this are mentioned in Circular No. NSDL/POLICY/2010/0059 dated May 28, 2010 issued to Participants.

Change in registration process for Clients registered for *IDeAS* facility through **DIRECT**

DIRECT (*Direct Ideas REGistration of Client account*) facilitates registration of depository accounts activated under the Individual category i.e. Resident-Ordinary, Resident-HUF, NRI-Repatriable, NRI-NonRepatriable and Foreign National-FN for *IDeAS* facility directly at NSDL.

NSDL has enhanced its *IDeAS* facility wherein account holder can now enter User ID of his/her choice at the time of registering for *IDeAS* facility through **DIRECT** and need not use the User Id allotted automatically by the system.

Further details about this facility are mentioned in Circular No. NSDL/POLICY/2010/0058 dated May 25, 2010, which is posted on NSDL website www.nsd.co.in.

Facility to view & change email ID on *IDeAS* facility

NSDL will be providing a facility to Users (i.e. Clients) of *IDeAS* to reset passwords themselves for Users who have forgotten the password by keying-in certain information on *IDeAS* website. The new password would be sent to their email address registered on *IDeAS* website. As a preparatory step to the above facility, *IDeAS* facility is being enhanced to facilitate Users to view / change their email addresses registered on *IDeAS*.

Capturing mobile numbers starting with 6 or 7 as the first digit

Considering that mobile companies have also started allotting mobile numbers with either "6" or "7" as the first digit, Participants have been informed that they can now capture in the DPM system ten digit mobile

Discontinuation of depository services from Service Centres

NSDL had vide Circular no. NSDL/PI/2002/0346 dated February 26, 2002 informed its Participants about the procedure to be followed in case of termination of franchisees. Participants are advised to follow the procedure as given below for discontinuing depository services from any type of service centre (branches, franchisees, collection centres, drop boxes or places called by any other name from where depository services are provided):

1. Advance notice of atleast 30 days about discontinuing of depository services to be given to all Clients, who are availing depository services through such service centre.
2. Clients who are being provided depository services through such service centre should be informed about the alternate arrangements made for availing the services.
3. Information should be given to NSDL about discontinuation of depository services from such service centre atleast 30 days in advance.

This has been informed to Participants vide Circular No. NSDL/POLICY/2010/0049 dated May 10, 2010.

Acceptance of proof of date of birth in case of minor clients

NSDL has informed its Participants about the procedure to be followed in case of acceptance of proof of date of birth for minor clients.

Participants have now been informed that they may accept a photocopy of birth certificate instead of attested or notarized birth certificate as proof of date of birth for minor clients provided the same is verified with the original. However, in case the client submits an original birth certificate, Participant can accept the same as proof of date of birth.

This has been informed to Participants vide Circular No. NSDL/POLICY/2010/0051 dated May 13, 2010.

Information for creation of database for SEBI Complaints Redress System (SCORES)

SEBI vide its letter no. OIAE/3959/2010 dated May 6, 2010 informed NSDL about upgrading the investor grievance redressal mechanism to a web-based centralized grievance redressal system. SEBI has therefore advised the Depositories to provide certain information about its Depository Participants in the prescribed format including the details about Compliance Officer’s name and their contact details and Service Centre details of the Participants.

NSDL will provide these details to SEBI as available in NSDL records based on the details provided by Participants. Participants can view the details of their Service Centres as available on the NSDL website (www.nsdl.co.in).

This has been informed to Participants vide Circular No. NSDL/POLICY/2010/0052 dated May 13, 2010.

NCDO training / certification programmes for Participants

NSDL conducts training and certification programmes for Participants to increase the availability of trained personnel for depository operations. In May 2010, such programmes were conducted in Agra, Ahmedabad, Bangalore, Bhopal, Calicut, Chennai, Dehradun, Jaipur, Kochi, Kolhapur, Kolkata, Mangalore, Mumbai, Nagpur, New Delhi, Rajkot, Surat and Trivandrum. 1,521 persons attended the training programmes conducted at these locations.

Know more about Application Supported by Blocked Amount (ASBA)

(continued from May 2010 issue)

5. Is it mandatory for investors eligible for ASBA, to apply through ASBA only?

No, it is not mandatory. An investor, who is eligible for ASBA, has the option of making application through ASBA or through the existing facility of applying with cheque.

6. Can I make application through ASBA facility in all issues?

Yes, you can make application through ASBA facility in all the issues i.e. public and rights.

7. Where should I submit my Application Supported by Blocked Amount (ASBA)? How shall I know which bank and which branch of that bank is the designated branch for accepting ASBA applications?

List of Self Certified Syndicate Banks (SCSBs) and their designed branches i.e. branches where ASBA application form can be submitted, is available on the websites of BSE (www.bseindia.com) and NSE (www.nseindia.com) and on the website of SEBI (www.sebi.gov.in). The list of SCSB would also be given in the ASBA application form.

8. What is Self Certified Syndicate Bank (SCSB)?

SCSB is a bank which is recognized as a bank capable of providing ASBA services to its customers. Names of such banks would appear in the list available on the website of SEBI. [Also see answer to question (6)]

9. Can I submit ASBA in any of the banks specified in the list of SCSBs?

No, ASBA can be submitted to the SCSB with which the investor is holding the bank account.

10. How many applications can be made from a bank account?

Five (5) applications can be made from a bank account per issue.

11. Am I required to submit ASBA only physically?

No, you can either fill up the physical ASBA form available with SCSB and submit the same to the SCSB or apply electronically/online through the internet banking facility (if provided by your SCSB).

12. Can I use the existing application form for public issues for applying through ASBA?

Investor is requested to check the form carefully. In case of public issue, the application form for ASBA will be different from the existing application form for public issues. The application forms will be available with designated branches of SCSB.

In case of **rights issue**, there will not be a separate form for ASBA. The investor has to apply by selecting ASBA option in Part A of the Composite Application Form.
