## NSDL launches ACE - Alerts to Clients through Email

NSDL sends SMS Alerts to Clients upon change of address in respect of their demat accounts. As a measure to further strengthen the risk containment mechanism, NSDL has launched a facility called **ACE - Alerts to Clients through Email**, whereby emails will be sent by NSDL to the email address (*captured in the Depository System*) of the account holder(s) in case of change of address. The salient features of ACE are as follows:

- The parameters for sending email alerts will be similar to SMS Alert facility.
- Email alerts will be sent to the email address of the account holder(s) available in the Depository System.
- Account holder(s) will receive email alerts from the Email ID : nsdl\_alerts@nsdl.com

Further details about this are available in Circular No. NSDL/POLICY/2010/0020 dated March 4, 2010.

## SMS Alert facility enhanced - Alerts for Credits

With effect from March 5, 2010, NSDL has enhanced its SMS Alert facility whereby Clients will receive alerts for credits (transfers) received in their

demat accounts. These SMS Alerts will be sent on the same day for credits received upto 7.00 pm. In respect of credits received after 7.00 pm, SMS Alerts will be sent on the following day.

Sample text message of SMS Alert is given below:

- (a) If the Client receives credit upto five ISINs in his/her demat account, the text message of the SMS alert would be as follows :

On \_\_\_\_\_ (date, dd/mm/yy), \_\_\_\_\_ (Quantity) \_\_\_\_\_ (Company Name), credited to your demat a/c no xxxx4086.. NSDL

- (b) If the Client receives credit of more than five ISINs in his/her demat account, the text message of the SMS alert would be as follows:

“Securities of more than 5 companies (ISINs) credited to ur demat a/c no xxxx5678 on \_\_\_\_\_ (date, dd/mm/yy). Check details with ur DP or on IDeAS website if subscribed.. NSDL”

With the above addition, SMS alerts are now being sent by NSDL to demat accountholders for the following:

## SEBI instructions on disclosure of investor complaints and arbitration details on Depository website

SEBI has vide its Circular No. SEBI/MRD/OIAE/Dep/Cir- 4/2010 dated January 29, 2010 clarified regarding disclosure of details of complaints lodged by investors (Beneficiary Owners) against Participants including details pertaining to arbitration and penal action against the Participants on depository's website. Such details will henceforth be displayed on NSDL's website.
