SMS Alert facility enhanced - SMS Alerts to Clients upon modification/cancellation of nominee name

As a risk mitigation measure and value added service, NSDL has enhanced its SMS Alert facility whereby SMS Alerts will be sent to clients in their mobile phones upon modification / cancellation of nominee name in their depository accounts.

The text of the SMS will be as follows:

1) Modification of nominee name:

"On _____ (date, dd/mm/yy), as per your instruction, name of _____ has been recorded as a nominee in ur demat a/c no xxxx4086..NSDL"

2) Cancellation / deletion of nominee name:

"On _____ (date, dd/mm/yy), as per your instruction, name of _____

has been cancelled as a nominee in ur demat a/c no xxxx4086..NSDL"

Further, the first 25 characters of the nominee name would be considered in the SMS message.

Operation of depository account of Qualified Foreign Investor (QFI) - 'QFI Client Search'

SEBI vide Circular No. CIR/ IMD/FII&C/3/2012 dated January 13, 2012 has informed that a QFI can open only one demat account with any one of the Participant and in case of jointly held demat accounts, each of the joint holders shall be deemed to be holding a demat account as a QFI. Further, no other demat account can be held by any of the QFI as a QFI or in any other capacity.

In view of the aforesaid, NSDL has provided a 'QFI Client Search' facility to Participants so as to make a search on the PAN of the QFI to ascertain whether any such depository account exists with such PAN captured against **any account holder across any type-subtype** in the depository system.

Know more about e-Voting system of NSDL

- 6) In case of demat accounts / share certificates held by joint holders, who will cast the vote in e-Voting system?
- Ans. As only one of the several joint holders is entitled to exercise voting right, in case of e-voting only first holder is recognized for the purpose of sending user ID & password for e-voting. Accordingly, the vote casted using the User ID and password sent to first holder is recognized on behalf of all the joint holders, as the shareholder who casts the vote through the e-Voting services of NSDL is doing so on behalf of all joint holders.
- 7) Is there any charge on the shareholders for using e-Voting system of NSDL?
- Ans. No. Currently, NSDL does not levy any charge on the shareholders for using the e-Voting system.

8) Will proxy be able to cast vote in e-Voting system?

- **Ans.** e-Voting system brings flexibility, convenience and ease of operation for the shareholder to cast vote through internet. This eliminates the need to appoint a proxy.
- 9) Is time period for e-Voting available to shareholders same as that of Postal Ballot?
- Ans. Yes. The time defined in the Postal Ballot Rules, 2001 for Postal Ballot is applicable for e-Voting as well.

10) Is there any User manual to understand the login and voting process?

Ans. Yes. You can download the User manual from (<u>https://www.evoting.nsdl.com</u>).
