Relaxation in timelines for compliance with regulatory requirements

In view of the extended lockdown period arising due to the COVID-19 pandemic, temporary relaxations in compliance with certain deadlines have been extended, as described below -

Simplified online process for NSDL demat account holders to avail SPEED-e facility

NSDL has launched a simple online process to enable demat account holders to avail NSDL's Internet based SPEED-e facility. The registration process can be completed online at NSDL e-Services website <https://eservices.nsd.com> without the need to visit office of DP.
