## **News**

### e-KYC Authentication facility by Entities in the securities market for Resident Investors

Entities in the securities market, as may be notified by the Central Government, shall be allowed to undertake Aadhaar Authentication under section 11A of the PMLA. These entities would be registered with UIDAI as KYC user agency (KUA) and shall allow all the SEBI registered intermediaries / mutual fund distributors to undertake Aadhaar Authentication of their clients for the purpose of KYC through them. The SEBI registered intermediaries / mutual fund distributors, who want to undertake Aadhaar authentication services through KUAs, shall enter into an agreement with any one KUA and get themselves registered with UIDAI as sub-KUAs. Upon notification by the Central Government / registration with UIDAI, the KUAs and sub KUAs shall adopt a prescribed process for Aadhaar e-KYC of investors (resident) in the securities market.

## Government of India notification regarding the Indian Stamp (Collection of Stamp-Duty through Stock Exchanges, Clearing Corporations and Depositories) Rules, 2019

Investors are requested to take note of the amendments to the Indian Stamp Act, 1899 which proposes to create the legal and institutional mechanism to enable states to collect stamp duty on securities market instruments at one place by one agency (through the Stock Exchanges or Clearing Corporations authorised by the stock exchange or by the Depositories) on one Instrument and subsequent disbursement of the duty collected to the respective states.

Accordingly, with effect from January 9, 2020, the depositories would be required to collect stamp duty from the transferor in case of off market transfers on the consideration amount specified by the transferor, in his/her delivery instruction, and from the pledgee in case of pledge invocation on the market value of the securities, as per the rates prescribed in the abovementioned act and rules framed thereunder.

#### Mapping of Unique Client Code (UCC) with demat account of the clients

To facilitate ease in reconciliation to detect diversion of clients' securities and to share information in respect of diversion of payout of securities to non-client/other client accounts, etc., mechanism as mentioned by SEBI shall be implemented for mapping of Unique Client Code (UCC) with the demat account of the clients.

## Streamlining the Process of Public Issue of Equity Shares and convertibles - Extension of timeline for implementation of Phase II of Unified Payments Interface (UPI) with ASBA

In order to ensure that the transition to UPI in ASBA is smooth for all the stakeholders, SEBI has extended the timeline for implementation of Phase II till March 31, 2020 with the revised timelines for the existing T+6 environment.
