SEBI has advised that Participants which have their own website, should display the below mentioned ticker on their website in order to create awareness among Clients that ASBA has been made mandatory payment mechanism for all investors including retail individual investors for all public issues opening on or after January 1, 2016:

"No need to issue cheques by investors while subscribing to IPO. Just write the bank account number and sign in the application form to authorise your bank to make payment in case of allotment. No worries for refund as the money remains in investor's account."

Swachh Bharat Cess

w.e.f. November 15, 2015, provisions of Swachh Bharat Cess (SBC) contained under Chapter VI of the Finance Act, 2015 are effective. Accordingly, Participants are requested to note that SBC would be charged @ 0.5% on the fees / charges payable by Participants and will be shown separately in the monthly bill. This will be applicable from the monthly bill of November 2015 onwards.
