### Transfer of securities only in demat form- Deadline extended till April 1, 2019

SEBI has extended the earlier deadline of December 5, 2018 for restriction on transfer of securities of listed companies in physical form to **April 1, 2019**. This means listed companies / their registrar and transfer agent can process the requests received from shareholders for transfer of shares etc. held in physical form till March 31, 2019. Accordingly, investors who are holding shares / other securities of any listed company in physical form and wish to transfer it to someone else, should submit their request for transfer well before March 31, 2019 to the company / its registrar and transfer agent. This timeline is not applicable for transmission and transposition requests.

### Procedure for minor correction in name of an individual in a demat account

In case minor correction in name of an individual demat account holder is desired, Participants need follow the procedure given below:

1. Minor correction in name is one that is obvious, easily explainable and raises no doubt that the name pertains to the same individual. This would include correction of spelling mistakes, if any, expansion of the name by incorporating the fully expanded name and/or inclusion of the middle name or abbreviation of name.
2. Participant need to collect an ink-signed written request signed by the client in whose name, correction is required. Any of following documents should be obtained along-with such request - PAN card, Aadhaar card, Passport, Driving Licence, Voter's Identity card, NREGA Job card, which carries the correct name.
3. A confirmation should be obtained from the client that it is not a change in name of the individual for any reason including due to marriage, divorce, court order, etc. In case, an individual changes the spelling of its name for any reason including for numerology, etc., it will be considered as a change in name, not a correction in name. Procedure to be followed in case of change in name of demat account holder is provided in circular NSDL/POLICY/2013/0033 dated February 27, 2013.
