Processing of Account Closure and Transmission Requests through 'Transfer of Holding' module only

It is observed that sometimes Participants use 'Account Transfer' module for transfer of securities to a target account which is also with a NSDL Participant. Participants are requested to use 'Transfer of Holding' module to process account closure and transmission requests in such cases. In respect of account closure or transmission requests where the target account is with other depository or in case of transmission in an account with multiple nominations, Participants may continue to process such requests through Inter-depository or Account Transfer module.

List of Basic Service Demat Accounts (BSDA) holding another Demat Account on NSDL Intranet Site - i-Assist

As per SEBI guidelines, an individual having more than one demat account as a sole / first holder across depositories is not eligible for BSDA facility. In this regard, NSDL communicates a list of accounts to DPs based on search carried out in the NSDL depository system (on the basis of First holder's PAN) and information received from other depository at the end of each month. The list of such identified accounts (text file) is hosted on **NSDL Intranet site - i-Assist** before 10th day of subsequent month under the link - 'Regular Accounts with Matching PAN' with report namely '**List of BSDA Accounts holding another Demat Account [Across Depositories]**'.

Participants are required to check the aforementioned list on a monthly basis, disable the BSDA flag in such accounts and send communication to respective clients informing about the change effected in the demat account.

UIDAI Circular on applicability of Aadhaar as an identity document for Non-Resident Indians (NRIs), Person of Indian Origin (PIOs) and Overseas Citizen of India (OCIs)

SEBI has informed about the UIDAI's Circular no. 6-1/2016- UIDAI (DBT) dated November 15, 2017 regarding applicability of Aadhaar as an identity document for NRIs, PIOs and OCIs. As per point no. 6 of this circular, requirement of getting Aadhaar is only in respect of those individuals who are entitled for it as per the Aadhaar Act, 2016. Further, as per the Aadhaar Act, 2016, reference may be drawn to Prevention of Money-laundering (Maintenance of Records) Rules, 2017 and Section 139AA of the Income Tax Act, 1961 which clearly stipulate that the linking of bank accounts and PAN respectively, is for those persons who are eligible to enroll for Aadhaar.

- **NISM / NSDL-DO training / certification programme for Participants**
To facilitate officials of Participants to prepare and appear for NISM-Series VI Depository Operations Certification Examination (DOCE), NSDL conducted a training programme at Bengaluru in January 2018.
- **CPE Training Programme for Participants**
NSDL, a NISM Accredited Continuing Professional Education (CPE) Provider offers CPE training programmes in different modules like Depository Operations, Mutual Fund, Currency Derivatives, Equity Derivatives, Securities Operations and Risk Management etc. for eligible associated persons. In January 2018, NSDL conducted 10 such training programmes at Ahmedabad, Chennai, Hyderabad, Kolkata, Mumbai and New Delhi.
- **Training Programme for Issuers and Registrar & Transfer Agents**
NSDL conducted a two day training programme on NSDL operations for staff of Issuers and Registrar & Transfer Agents at Mumbai in January 2018.
