### Amendments to Bye Laws

Participants are hereby notified that pursuant to Securities and Exchange Board of India (Depositories and Participants) (Amendment) Regulations, 2014 with respect to Single Registration for Depository Participants, Bye Law 6.1.3 has been amended as given below:

#### Amendment to Bye-Law 6.1.3

6.1.3. Every application shall be dealt with by the Depository within thirty days of receipt of such application and if the Depository is satisfied, it shall forward the same to the Securities and Exchange Board of India with the Depository's recommendations.

Provided that if the applicant is already registered as a Participant with SEBI through another Depository, the Depository may approve the application of the entity and inform SEBI after exercising due diligence and on being satisfied about the compliance of all relevant eligibility requirements including the following:

#### **Limited Purpose Holiday Master for DIS Monitoring**

SEBI had issued guidelines regarding standardization, monitoring and scanning of DIS. Accordingly, Participants were advised to enter details of DIS issued to Clients in DPM immediately but not later than two days and to scan and upload images of DIS executed by end of the next working day to DIVS. In order to determine what is a 'working day' for the above purpose, a Limited Purpose Holiday Master for DIS monitoring was notified for the calendar year 2015 (Ref. : NSDL Circular No. NSDL/POLICY/2015/0016 dated January 30, 2015). In the same manner, the Limited Purpose Holiday Master for DIS monitoring for the calendar year 2016 is mentioned vide NSDL circular no. NSDL/POLICY/2015/0119 dated December 28, 2015 issued to Participants which will be used for monitoring of upload of DIS issuance details in eDPM and scanned images in the DIVS of the Local DPM.
