### Launch of redemption of mutual fund units through SPEED-e facility

SPEED-e facility has been enhanced to enable clients to redeem **Mutual Fund Units**. This facility enables both type of users i.e. password and e-Token, based to give request to redeem the mutual fund units. It eliminates the need for Clients to submit Redemption Form (RF) to Participant for redemption of mutual fund units available in his/her demat account.

This was informed to Participants vide Circular No. NSDL/POLICY/2017/0072 dated December 7, 2017 and is available on NSDL website [www.nsd.co.in](http://www.nsd.co.in).
