A new rejection reason has been added in the list of reasons for rejection of dematerialisation request by Issuers/ RTAs:

Rejection Code	Rejection Reason
47*(Refer note)	Physical Shares transferred/transmitted to IEPF Demat Account

*The demat rejection code '47 - cancelled by investor' which was in use between October 23, 2009 and December 16, 2010 has been assigned a new code '98 - Cancelled by Investor'.

Participants are advised to incorporate the new rejection code '98 - Cancelled by Investor' in their back office system in place of '47 - cancelled by investor' to ensure that SOT/ Demat rejection request reports generated from back office system shows the proper rejection reason for the cancellation done in past.
