Modification of Client Type and Sub-type in respect of Write-off of shares held by FPIs

NSDL has provided a facility to Designated Depository Participants (DDPs) and Custodian of securities to modify the client type and client sub type in Client Maintenance Module in Local DPM version 7.33.

'Off-market' transfer of securities by Foreign Portfolio Investors (FPIs)

With a view to provide tax incentives for relocating foreign funds to International Financial Services Centre (IFSC) to make the IFSC in GIFT City a global financial hub, SEBI has decided that a FPI ('original fund' or its wholly owned special purpose vehicle) may approach its Designated Depository Participant (DDP) for approval of one-time 'off-market' transfer of its securities to the 'resultant fund'.

The DDP after appropriate due diligence may accord its approval. Relocation request will imply that the FPI has deemed to have applied for surrender of its registration and the DDP may be guided by the guidelines pertaining to surrender of FPI registration. The 'off-market' transfer shall be allowed without prejudice to provisions of tax laws and FEMA.

DDPs and Custodians are requested to take note of this. Participants are required to forward the audit report as per schedule given below to NSDL.

Implementation of Telecom Commercial Communications Customer Preference Regulations (TCCCPR), 2018

Participants are advised to register with the Telecom Service Providers so that SMS message headers can be allotted, identity and purpose of communication can be properly verified in all messages and voice calls. Further, Participants shall also register the template of the messages and take utmost care and priority to ensure effective and timely implementation of TCCCPR 2018.

Amendment to Business Rules - Document Processing Fee

A fee of ₹15,000 plus applicable taxes shall be charged to unlisted companies for processing documents in respect of withdrawal from depository in accordance with newly inserted Business Rule 21.1.7.3.

Extension in timeline for mandatory update of certain KYC attributes

Participants were informed earlier that -

- a) 6 KYC attributes shall be mandatory for new accounts opened from June 1, 2021.
- b) In respect of all existing accounts, Participants must verify that 6 KYC attributes are updated and wherever required, necessary communication is sent to their clients, to update the same on or before May 31, 2021.

NSDL had informed the Participants regarding extension of timeline for existing clients to July 31, 2021. SEBI has now decided to extend the deadline for making 6 KYC attributes mandatory for new accounts to July 1, 2021.

Enhancement of IDeAS and e-Voting Integration

Participants are aware that they can integrate their netbanking or broking website with the NSDL IDeAS so as to facilitate clients to access the IDeAS facility.

Participants may note that current functionalities of IDeAS Integration have been enhanced to facilitate evoting. Accordingly, Participants will have the choice of redirecting their clients from their netbanking / broking website to NSDL IDeAS facility or the evoting page within the IDeAS facility directly.

With this, the demat account holders will be able to cast their vote for securities where NSDL has been appointed as e-Voting Service Provider. Or they may be directed to the e-Voting page of other e-Voting Service Providers to cast vote without having a necessity of doing separate log-in.

e-Voting Facility

In order to increase the efficiency of the voting process, SEBI has decided to enable e-voting for all individual demat account holders by way of a single login through their demat account / depository's website / Depository Participants. Demat account holders would be able to cast their vote without having to register again with different e-Voting Service Providers. This shall be implemented in a phased manner.

Accordingly to enable individual shareholders to login and cast vote through their demat account, NSDL services have been enhanced. Process of login for Individual shareholders holding securities in demat mode with NSDL is provided as Annexure to circular. Issuer companies are required to incorporate this in their notice.

The listed companies are also required to provide details of the upcoming events requiring voting to the Depository. The depository will send SMS/email alerts to demat account holders at least 2 days prior to the date of the commencement of e-voting. In order to facilitate listed companies to provide details of upcoming events requiring voting, NSDL's Issuer Services Portal has been enhanced to include e-Voting feature. Issuers can access this enhanced feature w.e.f. May 31, 2021.

All the Issuers are requested to use the Issuer Portal https://issuer.nsdl.com/ for providing the information about upcoming events requiring voting.

Issuers who are already registered in Issuer Portal, can use existing login credentials to access e-Voting feature for providing details of upcoming events requiring voting). Those Issuers who have not yet registered can register themselves at the earliest.
