Inter Depository Transfers of Government Securities

NSDL Depository System will be enhanced to allow market transfers for Government Securities between the Depositories through the “Inter Depository Transfer” module. As per relevant RBI notification, Participants need to comply with the norms laid down by RBI regarding the board-approved risk management process and audit oversight before accepting transactions in Government Securities. Participants are advised to ensure compliance and inform to NSDL in the prescribed format to enable NSDL to facilitate IDT of Government Securities.

Margin obligations to be given by way of Pledge/ Re-pledge in the Depository System

SEBI has directed that to mitigate the risk of misappropriation or misuse of client's securities available with the Trading members (TM) / Clearing members (CM) / Depository Participants, with effect from June 01, 2020, TM / CM shall accept collateral from clients in the form of securities, only by way of 'margin pledge', created in the Depository system. Transfer of securities to the demat account of the TM / CM for margin purposes shall be prohibited. In case, a client has given a power of attorney in favour of a TM / CM, such holding of power of attorney shall not be considered as equivalent to the collection of margin by the TM / CM in respect of securities held in the demat account of the client.
