SMS Alert facility enhanced – SMS Alerts to Clients for Blocking/Debit of shares in demat account in respect of Tender Offer instruction

With effect from April 14, 2018, NSDL has enhanced its SMS Alert facility whereby clients will receive SMS alerts in respect of following events pertaining to instruction submitted for the purpose of acquisition of shares by the company pursuant to Tender-Offers through Stock Exchange Mechanism:

- Blocking of shares in the demat account of the client
- Debit of shares from the demat account of the client
