Upload of account transfer instructions in new file format

With effect from November 17, 2018, Participants need to upload account transfer instructions in new file format only. Participants executing off-market transaction directly through front end on eDPM are required to enter payment details for off-market transfers with reason as ‘off-market sale’.

Streamlining the Process of Public Issue of Equity Shares and convertibles

SEBI has decided to introduce the use of Unified Payments Interface (UPI) as a payment option with Application Supported by Block Amount (ASBA) for applications in public issues by retail individual investors through intermediaries. The proposed process would increase efficiency, eliminate the need for manual intervention at various stages and will reduce the time duration from issue closure to listing by upto 3 working days. This mechanism would be introduced in different phases.
