Implementation of features in DPM for handling of Clients' Securities by TM/CM

NSDL has added the new sub types "Client Margin Trading Securities account" and "Client Collateral Account" in Client Maintenance module of DPM to facilitate opening of new demat accounts. Further, following enhancements have also been implemented in the DPM -

1. Enhancement in Power of Attorney (PoA) module.
2. Incorporation of validations for Pledge and transfer of securities from Client collateral account, Client margin trading securities account and Client unpaid securities account to Banks/NBFCs.
