3. Roadmap for introduction of T+1 rolling settlement cycle in equity market

Securities and Exchange Board of India (SEBI) on September 07, 2021, permitted stock exchanges to introduce T+1 settlement cycle on any of the securities available in the equity segment.

Market Infrastructure Institutions like Stock Exchanges, Clearing Corporations and Depositories have finalized the roadmap for the implementation of T+1 settlement cycle. Accordingly, T+1 settlement cycle will be implemented in a phased manner and the first list of securities with T+1 settlement cycle will begin from trade date starting from **February 25, 2022.**

4. Amendment in Bye Laws of NSDL regarding 'Hold on Securities'

NSDL has amended Bye Law 9.15 pertaining to 'Hold on Securities'. Participants are requested to take note of the same and ensure compliance.

5. Systemic check using distinctive numbers database in corporate actions executed between depositories

In consultation with SEBI, NSDL has introduced systemic check using database of distinctive numbers while executing corporate action between depositories i.e. for any corporate actions where credits are to be effected in one depository after debits are successfully executed in the other depository.

Accordingly, Issuers/R&T Agents are advised as follows:

- Issuer/R&T Agents shall ensure to use the details CA Type Code, Allotment Description Code and Flag for status of DN Range for specified corporate action transaction.
- While executing debit corporate action in respect of accounts in NSDL, Issuer/R&T Agents shall provide details in prescribed format for specified debit corporate action transaction. Upon effecting of debits in respect of accounts in NSDL, the said information will be provided to CDSL through the DN database.
- While executing credit corporate action in respect of accounts in NSDL consequent to debits effected in CDSL, the Issuer/R&T Agents shall provide the details in prescribed format for the credit corporate action after verifying that the debits are effected in accounts in CDSL. In case such details do not match, such credit corporate action shall be rejected and the reasons will be notified.

DPM-SHR version 7.8.15 was released on October 22, 2021 facilitating Issuers / R & T Agents to provide above systematic check.

6. Extension of time for submission of networth certificate and/or audited financial statements

NSDL has extended the timeline for submission of networth certificate/audited financial statements for the financial year 2020-21 to January 15, 2022. Accordingly, Participants are requested to ensure that they submit the audited financial statements and networth certificate in the prescribed format, on or before January 15, 2022.

7. <u>Discontinuation of usage of pool accounts for transactions in units of Mutual Funds on the Stock Exchange Platforms</u>

As directed by SEBI -

a. Pooling of funds and/ or units by stock brokers / clearing members in any form or manner shall be discontinued for mutual fund transactions.

b. Stock exchanges shall put necessary mechanisms in place for stock brokers /clearing members to ensure that funds pay-in is directly received by the clearing corporation from the investor's account and funds pay-out is directly made to the investor' account. Pay-in / pay-out of funds shall not be handled by the stock brokers / clearing members. In the same manner, for both demat and non-demat mode transactions, the units shall be credited and debited directly to/ from the investors' demat account/ folio account without routing it through the pool account of the stock brokers / clearing members. However, for redemption of units held in dematerialised mode, the practice of issuance of Delivery Instruction Slip (DIS - physical or electronic) to the Depository Participant to debit the units for delivery to clearing corporation, may continue.

It is further clarified that stock brokers / clearing members facilitating mutual fund transactions shall:

- a. not accept mandates for SIPs or Lumpsum transactions in their name;
- b. accept cheque payments from investors issued in favor of the respective SEBI recognized Clearing Corporations or mutual fund scheme(s) only;
- c. not accept or handle funds or units of investors in their proprietary accounts or pool accounts in any form or manner; and
- d. not accept payment through one-time mandate or issuance of mandates/instruments in their name for mutual fund transactions. However, one-time mandates in favour of SEBI recognized Clearing Corporations may be accepted.

The provisions of SEBI Circular shall be applicable with effect from April 01, 2022.

8. <u>Facility to submit Quarterly Report on Artificial Intelligence (AI) and Machine Learning (ML) applications and systems offered and used by market intermediaries on e-Pass</u>

NSDL has developed a facility for submission of quarterly report on AI and ML through online portal -e-PASS (https://www.epass.nsdl.com/). Participants can submit the quarterly report of Artificial Intelligence (AI) and Machine Learning (ML) on e-PASS system from the quarter ended September 30, 2021 onwards on e-PASS platform.

9. Amendments to Business Rules of NSDL - Mutual Funds Conversion

NSDL has amended FORM 2 (Conversion Request Form for Mutual Fund Units represented by Statement of Account) of Business Rules of NSDL.

10. Mandatory update of certain attributes of KYC of clients- Extension

As directed by SEBI, the timeline for verification of 6 KYC attributes for existing clients has been extended to December 31, 2021. Participants are advised to take all possible measures so that the client accounts are compliant before the above mentioned timeline.

11. Simplification of procedure for Early Redemption of Sovereign Gold Bonds

Participants are hereby informed that the details of early redemption requests for Sovereign Gold Bonds generated electronically under Repurchase/Redemption module are not required to be submitted separately to NSDL by email.

13. Incorporation of new freeze reason code in DPM

All Participants are hereby informed that the following new freeze reason code has been introduced in DPM -

Freeze Reason Code	Freeze Reason Description
36	Non-payment of ALF*

* ALF- Annual Listing Fees

The aforesaid freeze reason code can be executed only by NSDL and is for display/view for Participants. The aforesaid freeze reason code will not be displayed to Participants in list of freeze reason codes available under freeze execution module in depository system for executing the freeze.

14. <u>Amendment to SEBI circular pursuant to comprehensive review of Investor Grievance Redressal Mechanism</u>

i. Clause 1.H. Place of arbitration / appellate arbitration is replaced as under:

In case award amount is more than ₹50 lakh, the next level of proceedings (arbitration or appellate arbitration) may take place at the nearest metro city, if desired by any of the party involved. The additional statutory cost for arbitration, if any, to be borne by party desirous of shifting the place of arbitration.

ii. Clause 1.J. - Speeding up grievance redressal mechanism is modified as under:

- (v) In all cases except the additional fees charged from the trading members, if the claim is filed beyond the timeline prescribed in column 3, (only for member), on issue of the arbitral award the stock exchange shall refund the deposit to the party in whose favour the award has been passed.
- **(vi)** The additional fees charged from the trading members, if the claim is filed beyond the timeline prescribed in column 3, (only for member), if any, to be deposited in the IPF of the respective Stock Exchange.
