New Rule 21.2.2.3, NSDL Fees for hold on securities for Non-Disposal Undertakings / Agreement (NDU) has been inserted in Business Rules. Participant of Client on whose securities hold is created for NDU shall be charged @ 0.01% of the value of securities upon creation of hold, subject to a minimum of ₹ 25.”
