Database for Distinctive Number (DN) of Shares - Action against non-compliant companies

SEBI has directed Depositories to take action against companies which are not in compliance with SEBI's circular no. CIR/MRD/DP/10/2015 dated June 05, 2015 regarding Database for Distinctive Number (DN) of Shares. Action includes freezing of all the securities held by the promoters and directors, not carry out any transfer by way of sale, pledge, etc., of any of the securities and freeze all related corporate benefits on the Beneficiary Owner a/c frozen till such time the company complies with the directions provided in SEBI circular.
