Mandatory update of certain attributes of KYC of clients

All Participants are informed that 6 KYC attributes namely Name, Address, PAN, Valid mobile number, Valid email ID and Income range shall be mandatory for new accounts opened from June 1, 2021 for all the categories of clients.

- In respect of all existing accounts, Participants must verify that all 6 KYC attributes are Updated.
 Wherever required, necessary communication should be sent to the clients to update the same, on or before May 31, 2021.
- Participants shall inform the clients through both physical and electronic modes and also through its website, if any, for updating the details and completing the validation process.
- Thereafter, non-compliant demat accounts will be liable to be made inactive i.e. no debit will be allowed in such demat accounts (except for settlement of already open positions).

Enhancement of Issuer services on NSDL Issuer portal

As a part of our continuous endeavour to service the Issuers/RTAs, NSDL has enhanced its issuer portal. For issuance of Commercial Paper, Issuers / RTAs may make online application for allotment of ISIN and for execution of corporate action through Issuer portal.

Transfer of business by SEBI registered intermediaries to other legal entity

SEBI has issued following clarifications regarding transfer of business by SEBI registered intermediaries to other legal entity.

1. The transferee shall obtain fresh registration from SEBI in the same capacity before the transfer of business if it is not registered with SEBI in the same capacity. SEBI shall issue new registration number to transferee, different from transferor's registration number in the following scenario:

Business is transferred through regulatory process (pursuant to merger / amalgamation / corporate restructuring by way of order of primary regulator / Govt. / NCLT, etc.) or non-regulatory process (as per private agreement / MOU pursuant to commercial dealing / private arrangement) irrespective of transferor continues to exist or ceases to exist after the said transfer.

- 2. In case of change in control pursuant to both regulatory process and non-regulatory process, prior approval and fresh registration shall be obtained. While granting fresh registration to same legal entity pursuant to change in control, same registration number shall be retained.
- 3. If the transferor ceases to exist, its certificate of registration shall be surrendered.
- 4. In case of complete transfer of business by transferor, it shall surrender its certificate of registration.
- 5. In case of partial transfer of business by transferor, it can continue to hold certificate of registration.

Prior Approval for Change in control: Transfer of shareholdings among immediate relatives and transmission of shareholdings and their effect on change in control

SEBI has specified the procedure for seeking prior approval for transfer of shareholding among immediate relatives and transmission of shareholding as mentioned below:

- 1. Transfer / transmission of shareholding in case of body corporate type intermediary.
- 2. Transfer / transmission of shareholding in case of a proprietary firm type intermediary.
- 3. Transfer / transmission of ownership interest in case of partnership firm type intermediary.
- 4. Incoming entities/shareholders becoming part of controlling interest in the intermediary pursuant to transfer of shares from immediate relative / transmission of shares (immediate relative or not), need to satisfy the fit and proper person criteria stipulated in Schedule II of SEBI (Intermediaries) Regulations, 2008.

Clarification on downloading KYC Documents of Clients from KRA's System

While opening an online account demat based on KYC details downloaded from KRA's system, Participant should display KYC details as downloaded from KRA's system to the client. Client must confirm that there is no change in the particulars as downloaded from KRA and in case of any change, the client must be provided an option to provide latest details along with supporting documentation.

Central KYC Registry (CKYCR) is fully operational for individual clients and Legal Entities (LE) also. Accordingly, Reporting Intermediaries can upload the KYC records of LE accounts opened on or after April 01, 2021 on to CKYCR in the specified template in the CKYCR test environment (https://testbed.ckycindia.in/ckyc/index.php).
