SEBI Circular on e-Voting Facility Provided by Listed Entities

In order to increase the efficiency of the voting process, SEBI has decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register with different e-Voting Service Providers (ESPs). The facility shall be available to all individual shareholders holding the securities in demat mode. Participants are advised to request their clients to update their mobile number and email ID in order to enable them to access e-voting facility.

Relaxation in timelines for Internal / Concurrent Audit of depository operations

SEBI has extended the deadline for submission of half yearly Internal Audit Report (IAR) by Participants for half year ended September 30, 2020 to December 31, 2020. Accordingly, the Internal/concurrent audit report for the audit period of April 1, 2020 to September 30, 2020 needs to be submitted through e-PASS platform by December 31, 2020.

SEBI Circular on Operational Guidelines for Transfer and Dematerialization of re-lodged physical shares

SEBI has fixed March 31, 2021 as the cut-off date for re-lodgment of transfer requests and has stipulated that such transferred shares shall be issued only in demat mode. In view of the aforesaid, the updated operational guidelines for crediting the transferred shares into the respective demat account of the investor, have been issued.

SEBI has extended the timelines for compliance with the following regulatory requirements by Depository Participants:

II	KYC application form and supporting documents of the clients to be uploaded on system of KRA within 10 working days	Period of exclusion shall be from March 23, 2020 till December 31, 2020. A 15-day time period after December 31, 2020 is allowed to Depository / DPs, to clear the back log.
III	Systems audit on annual basis for the financial year ended March 31, 2020	December 31, 2020

Introduction of Unified Payments Interface (UPI) mechanism and Application through Online interface and Streamlining the process of Public issues of securities

SEBI has introduced Unified Payments Interface (UPI) mechanism and an additional mode for application through online (app / web) interface in public issues of securities. It has decided to introduce the following in addition to the already specified modes under the ASBA Circular:

- Providing an option to investors to apply in public issues of debt securities through the app / web interface of Stock Exchange(s) with a facility to block funds through Unified Payments Interface (UPI) mechanism for application value upto ₹ 2 Lakh.
- Permitting the UPI mechanism to block funds for application value upto ₹ 2 Lakh submitted through intermediaries (Syndicate members, Registered Stock Brokers, Registrar and Transfer agent and Depository Participants).
