On successful upgradation / installation, Participants can access both the services i.e. Local DPM as well as DPM Plus+ through a single sign-on. Following are the features in DPM Plus+ (Version 1):

- 1) Single Sign-on
- 2) Billing
- 3) Integration with NDML-KRA for KRA upload
- 4) Client Creation (Type-Individual)
- 5) Generation of Transaction cum SOH (TS) with Price and Value
- 6) Client Master List (enhanced)
- 7) Sending of Client Master List and TS & SOH through email
- 8) DP MIS Reports

Participants may note that DPM Plus+ will be continuously augmented and the new features will be released at regular intervals. Amendments to Business Rules of NSDL - OTP for off-market transfer

Business Rule 12.3.1 of NSDL - OTP for off-market transfer has been amended as follows:

12.3.1 - Transfer of securities in respect of off market trades shall be effected on receipt of a duly filled in securities transfer instruction form from the Clients for delivery as well as a securities transfer instruction form from the Clients for receipt and after obtaining client's consent through One Time Password (OTP). The specimen of these forms have been laid out in Form 12 and Form 14 respectively as specified in Rule 12.2.1 above. Alternatively, a Client may give standing instructions to its Participant to credit its account, provided that in case the client has a joint account, any one holder may provide such a client consent through OTP.

12.3.2. The Participant should check for the completeness of the form and validity of the signature of the Client before effecting such transfers.
