Recording consideration amount in case of Pledge Invocation

According to provisions of Indian Stamp (Collection of Stamp-Duty through Stock Exchanges, Clearing Corporations and Depositories) Rules, 2019, in case of transfer of securities pursuant to invocation of pledge, duty shall be collected from the pledgee on the market value of the securities. Therefore, Participants are requested to obtain consideration in case of pledge invocation from the pledgee in the prescribed format along with the Pledge/ Hypothecation Form (Form 28).
