#### 3. Linking of PAN with Aadhaar

Central Board of Direct Taxes (CBDT) has extended the timeline for linking of PAN with Aadhaar from March 31, 2022 to March 31, 2023. In case PAN is not linked with Aadhaar on or before March 31, 2023, it will be considered as invalid with effect from April 1, 2023.

This requirement should be widely disseminated by DPs for continual and smooth transactions by the investors in the securities market and to avoid any consequence of non-compliance thereof.

#### 4. Incorporation of new freeze reason code in DPM

NSDL has introduced following new freeze reason code in the DPM as below:

Freeze Reason Code	Freeze Reason Description
39	Account holder related - PAN inoperative

Participants are advised to make necessary changes in their static data code in respect of the back office interface with eDPM / Local DPM.

## 6. <u>Clarification by SEBI on discontinuation of usage of pool account for transactions in the units of Mutual Funds</u>

SEBI has clarified on various modalities for discontinuation of the pooling by Mutual Fund Distributors, Investment Advisers, Mutual Fund Utilities, Channel Partners etc., measures to prevent third-party payments and to safeguard the interest of unitholders with comes into effect from April 01, 2022 except for the requirement at clause 2.4 mentioned in SEBI circular which shall be applicable with effect from April 15, 2022.

## 7. <u>Automation of disclosure requirements under SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 - System Driven Disclosures - Ease of doing business</u>

- SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 has been amended to do away with manual filing for most of the transactions with effect from April 01, 2022. Thus transactions undertaken in the depository system do not require manual filing except for certain transactions where disclosure shall continue to be filed.
- Depositories shall also devise an appropriate mechanism to record all types of outstanding encumbrances in the depository system by June 30, 2022.
- Depositories shall provide information to the Stock Exchanges for the transactions recorded in the depository. Stock Exchanges will consolidate the information received from both the depositories and disseminate the same on their website as per the formats specified by SEBI.
- Stock Exchanges shall also devise an appropriate mechanism for dissemination of disclosures under SDD in a simple readable pdf format.
- This circular shall come into effect from July 01, 2022.

- Processing of Requests for Name Deletion / Name Change / Transposition
- Processing of Requests for Consolidation / Split / Replacement of Share
- Certificates / Amalgamation of Folios
- Handling Investor Correspondence / Grievances / SCORES complaint
- Processing of the demat requests

NSDL has enhanced DPM Plus facility to include an online option for closure of demat account by Clients.

#### 10. Approach to securities market data access and terms of usage of data

SEBI has advised all market intermediaries including the other data sources in Indian securities markets to make note of the following:

"As far as the data provided by various data sources in Indian securities markets pursuant to regulatory mandates for reporting an disclosure in public domain are concerned, such data should be made available to users, 'free of charge' both for 'viewing' the data as also for download in the format as specified by regulatory mandate for reporting, as well as their usage for the value addition purposes."

Further, apart from the data made available free of cost, data which is chargeable should be appropriately identified as such in public domain.

## 11. Nomination for Eligible Trading and Demat Accounts - Extension of timelines and relaxations for existing account holders

Participants are aware that SEBI had informed that Investors opening new trading and or demat account(s) on or after October 01, 2021, shall have the choice of providing nomination or opting out nomination.

The timeline for freezing of accounts for all existing eligible trading and demat account holders who have not provide choice of nomination has been extended from March 31, 2022 to March 31, 2023.

Requirements w.r.t. re-submission of nomination details shall be optional for the existing investors who have already provided the nomination details prior to issuance of the prescribed SEBI Circular.

Existing investors who have not submitted nomination details till date and intend to submit their nomination or opt out of nomination (not to nominate any one) may also be allowed to do so by way of two factor authentication (2FA) login on the internet trading platform for Stock Brokers/Depository Participants providing such services.

The details previously required in the form - mobile number, e-mail ID and identification details of the nominee(s)/ guardian(s) of the minor nominee(s) have been made optional. The revised format of the nomination form is given in Annexure – A to SEBI circular dated February 24, 2022.

#### 12. Corrigendum to Master Circular for Depositories dated February 05, 2021

Attention of Participants is invited to SEBI Circular No. SEBI/HO/MRD2/DDAP/CIR/P/2022/20 dated February 17, 2022 regarding Corrigendum to Master Circular for Depositories dated February 05, 2021 on opening of demat account in case of HUF. In abovementioned circular, SEBI stated as below:

In partial modification, Subsection 1.2(a) of Section 1.4 of the Master Circular for Depositories dated February 05, 2021 shall be replaced with the following:

"In the event of death of Karta of HUF, the name of the deceased Karta in the Beneficial Owner (BO) account shall be replaced by the new Karta appointed by the member of the HUF who in such a case shall be senior most member of the family"

NSDL Bye Laws has been amended to include the following:

**9.1.7** - The joint holders in client account may authorise jointly or any one of the holders or survivor(s) to operate the Client account in the form and manner as specified in the Business Rules.

Business Rule related to Account Opening Form for Individuals has also been amended.
