## Extension of date for wavier of settlement fee on transactions in mutual fund units in the depository system

The readers are aware that NSDL had decided not to charge any fee to Participants till September 30, 2010 in respect of transactions in mutual fund units routed through the stock exchange platform, which are held in the depository system.

To encourage investors to hold mutual fund units in the depository system, it has now been decided to continue not to charge any fee to Participants in respect of transactions in mutual fund units held in the depository system till March 31, 2011.

This has been informed to Participants vide Circular Nos. NSDL/POLICY/2010/0034 dated March 30, 2010 and NSDL/POLICY/2010/0105 dated September 22, 2010, which is posted on NSDL website [www.nsd.co.in](http://www.nsd.co.in).

## Transferability of Mutual Fund Units

SEBI vide Circular No. CIR/IMD/DF/10/2010 dated August 18, 2010 has informed regarding

‘Transferability of Mutual Fund Units’. In pursuance of the aforesaid SEBI Circular, NSDL has informed all its Participants that with effect from October 1, 2010 the depository system has facilitated transferability of mutual fund units (security type code ‘20’) from one depository account to another depository account.

Further detail about this facility is mentioned in Circular No. NSDL/POLICY/2010/0109 dated September 30, 2010.

## NCDO training / certification programmes for Participants

NSDL conducts training and certification programmes for Participants to increase the availability of trained personnel for depository operations. In September 2010, such programmes were conducted in Ahmedabad, Bangalore, Bareilly, Chandigarh, Hyderabad, Jodhpur, Kochi, Kolkata, Ludhiana, Mumbai, Mysore, Nagpur, New Delhi, Panchkula, Patna, Raipur, Tirupati and Udaipur. In all, 1,789 persons attended the training programmes conducted at these locations.

## TOPIC OF INTEREST

### Hold Mutual Fund Units in demat form

NSDL has provided a facility for investors to submit request for conversion of their mutual fund units represented by Statement of Account into dematerialised form through its Participants. Procedure for conversion of Mutual Fund Units into dematerialised form through your Depository Participant (DP) is mentioned below:

#### 1. Procedure for conversion of Mutual Fund Units into dematerialised form through your Depository Participant (DP)

- Obtain Conversion Request Form (CRF) from your DP.
- Fill-up the CRF.
- Submit the CRF alongwith the Statement of Account to your DP.
- After due verification, the DP would send the CRF and Statement of Account to the Asset Management Company (AMC) / Registrar and Transfer Agent (RTA).
- The AMC / RTA will after due verification confirm the conversion request sent by your DP and credit the mutual fund units in your demat account.

#### 2. Subscription

You can subscribe for mutual fund units through your Stock Broker using the Stock Exchange platform. Upon subscription, the AMC / RTA will credit the mutual fund units to your demat account.

#### 3. Redemption

You can redeem your mutual fund units held in dematerialised form through two different modes i.e., through your DP or stock broker.

##### • Redemption through DP

- Obtain Redemption or Repurchase Request Form (RF) from your DP.
- After due verification, your DP will send the RF to the AMC / RTA.
- The AMC / RTA will verify the form and confirm the redemption request and make the payment as per your bank account details available in the depository system.

##### • Redemption through stock broker

- Place your order through your Stock Broker using the stock exchange platform. You will be required to submit Delivery Instruction Slip (DIS) to your DP to transfer the mutual fund units to a designated Pool account of the Clearing Corporation (CC) of the stock exchange. The designated Pool accounts are given below:

- The redemption proceeds will be paid by AMC / RTA as per your bank account details available in the depository system.

With effect from October 1, 2010 NSDL depository system has facilitated transferability of mutual fund units (security type code '20') from one depository account to another depository account.

Moreover, NSDL has decided not to charge any fee to the Participants in respect of transactions in mutual fund units routed through the stock exchange platform, which are held in the depository system till March 31, 2011.
