This handbook will help the reader to understand procedures relating to different transactions in the depository system and will help prepare for NCFM test on NSDL Depository Operations Module. This handbook will be given to every candidate who enrolls for the certification programme. It can also be purchased at a cost of Rs. 100/- from NSDL.

**SEBI's announcement of modalities for introducing the settlement system for direct delivery of securities to the Investors**

In order to ensure that securities are quickly moved to the beneficiary account of the investor, SEBI had announced vide Press Release No. PR 20/2001 dated January 23, 2001 that, with effect from April 2, 2001, Clearing Member will have to transfer the securities to the beneficiary account of investor within **four calendar days** or **two working days**, whichever is later. Prior to this effective date, the time limit given to clearing members was six working days, after the pay-out day.

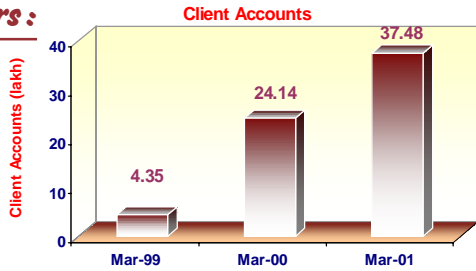

### Investors :

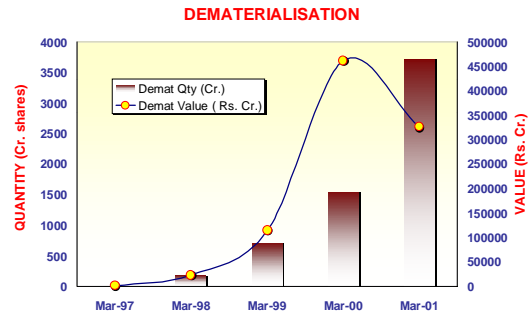


As on March 31 2001, 37,48,090 Investor accounts have been opened from within the country and abroad.

Besides, 3811 clearing member accounts have been opened to facilitate trading and settlement of demat shares in the stock exchanges connected to NSDL.

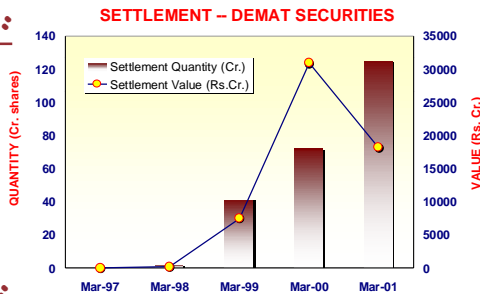
### Dematerialisation :

As on March 31, 2001, 3,721 cr. shares having a value of Rs. 3,26,184 cr. were dematerialised.



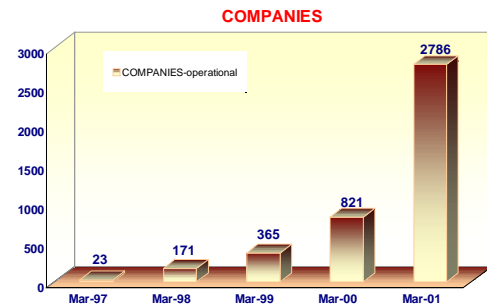

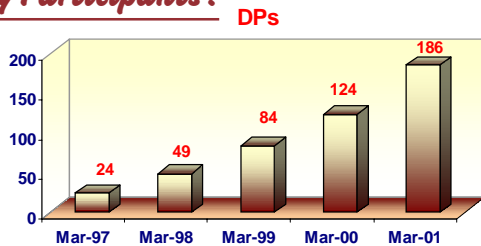

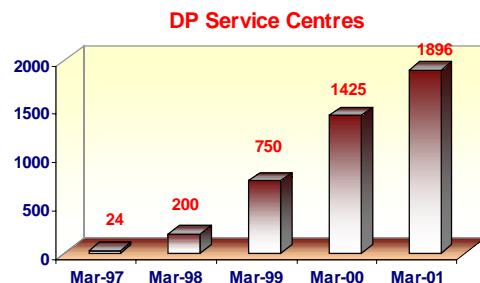

## Topic of Interest

### Preparedness for Rolling Settlements

SEBI in its press release (ref no. PR 51/2001) dated March 16, 2001 made an announcement that the following scrips would be traded only in rolling settlement by July 2001:

- All scrips which are included in the ALBM/BLESS or MCFS in any stock exchange will be traded ONLY in the compulsory rolling settlement on a nation wide basis i.e. on all the stock exchanges from July 2, 2001.
- In addition, if there is any scrip which is included in the BSE 200 list, but not covered by the above list, will also be included in the compulsory rolling settlement on a nationwide basis.

In rolling settlement on T+5 basis, the trading period (T) is one day. Obligations are worked out on the basis of the day's trade by the broker. The obligations have to be settled on the 5th working day after the trading day. Typically, a trade done on a Monday will be settled on the next Monday. Thus, there will be a settlement every day. Since, everyday will be settlement day in the rolling settlement regime, depository participant will have to get ready to handle settlement related activity everyday for all exchanges.

In order to gear up to the challenge of settling trades every day on a rolling basis, SEBI has advised the DPs to instruct their clients to submit the settlement instructions two days (one day in case of auction) prior to the pay-in date in case of rolling settlements. DPs may educate their clients about the need to submit settlement instructions well in time as prescribed by SEBI. NSDL has issued a detailed circular in this regard. Further, the following facilities available in NSDL depository system may be used to efficiently handle rolling settlement related operations.

- **The facility of giving future dated instructions**

An investor can specify the date on which the securities must be moved out of its account while giving a delivery instruction to its DP. This can be a future date and is known as the Execution Date. The investor can use this facility by issuing instructions with a future Execution Date to its DP immediately on confirmation of sale by the broker. This facility is particularly useful for investors having accounts at locations where DPs do not have direct connectivity to NSDL's central system. DPs may encourage their clients to use this feature to ensure that settlements are completed in a timely manner.

**• Auto Delivery Out facility**

NSDL has provided a facility for Clearing Members (brokers) whereby securities automatically move from the account of the clearing member (CM) to the account of the clearing corporation/house (CC/CH). This movement is carried out on the basis of an instruction by CC/CH to NSDL based on the obligations of the CMs. This is an optional facility for the CMs. CMs can avail of this facility only if the concerned CC/CH has opted for this facility. CMs are encouraged to avail of this option. This would eliminate the need of the CMs to give pay-in (delivery-out) instructions daily to the DPs. The clearing members will be left to handle only exceptional cases.

**• SPEED, an Internet based facility for the brokers (Clearing Members) to view and download the securities balances and transactions relating to their CM Pool Accounts on the Internet**

SPEED enables the Clearing Member (CM) to view and download its holding and transaction statement for its pool account. It can view the securities received by it into its pool account from its Clients for the purpose of pay-in. It can also view its instructions which are in Overdue status viz; awaiting delivery of securities from Clients. On that basis, CM can follow-up with its Clients for shortages in deliveries. It can also view the securities received into its pool account from the Clearing Corporation on pay-out. This is particularly useful when there are multiple settlements everyday. CMs are encouraged to use this facility.
