#### **SEBI announces modalities to introduce the settlement system for direct delivery of securities to the investors (Press Release Ref. No.20/2001)**

In order to ensure that the securities are moved quickly to the beneficiary account of the investor, the following decisions were made:

##### ***Effective from February 12, 2001***

- ⇒ Clearing Member will have to transfer securities to the beneficiary account of investor within **six calendar days** after pay-out day, instead of the existing limit of fifteen days after pay-out day.
- ⇒ If balances are still lying in the pool account of the Clearing Member after the aforesaid deadline, then such balances would
  - ⇒ not be eligible for delivery in subsequent settlement (s)
  - ⇒ not be eligible for pledging or stock lending purpose
  - ⇒ attract a penalty at the rate of 6 basis points per week calculated on First-In-First-Out basis on the value of securities lying in the pool account. The penalty so collected shall be earmarked by the depository for defraying the expenses in connection with investors' education and awareness.

##### ***Effective from March 5, 2001***

- ⇒ Securities lying in the pool account of the Clearing Member after the aforesaid deadline will be identified on the basis of settlement numbers instead of FIFO basis for the above purpose. The clearing corporation/house shall provide the settlement wise details of securities to the depositories and depositories shall maintain the settlement wise records for the purpose.

##### ***Effective from April 2, 2001***

- ⇒ The time limit of six calendar days for clearing member to transfer securities to the beneficiary account will be reduced to **four calendar days** or **two working days**, whichever is later.
- ⇒ SEBI has directed stock exchanges to introduce the system to transfer securities directly to the beneficiary account of investor instead of the pool account of the Clearing Member to the maximum extent possible.

#### **Deadline extended for qualifying certification programme**

NSDL has extended the deadline for mandatory appointment of atleast one person qualified in Depository Operations Module of NCFM at each service center to June 30, 2001. NSDL will levy a fine of Rs. 100 per day per service center for continued default beyond June 30, 2001.

#### **Reduction in software charges by 50% for scaled down version of DPM**

Considering the need for expanding direct depository services in smaller centers as well, NSDL has reduced its software charges for the scaled down version of DPM by 50%. Now, the scaled down version of DPM software will be available at Rs. 1,25,000 instead of Rs. 2,50,000.

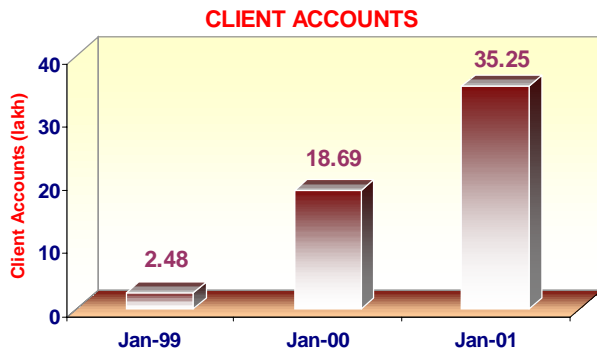
#### **Reduction in settlement fees charged on the clearing member (broker) accounts**

With effect from January 1, 2001, the minimum fee charged to DPs per quarter per CM account for pay-outs received is reduced to Rs. 1000 from Rs. 2000. The maximum ceiling per quarter per CM account continues to be at Rs. 20,000.

### Investors :

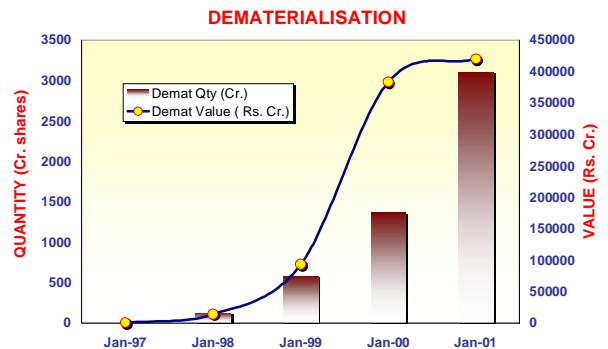


As on January 27, 2001, 35,25,664 Investor accounts have been opened from within the country and abroad.

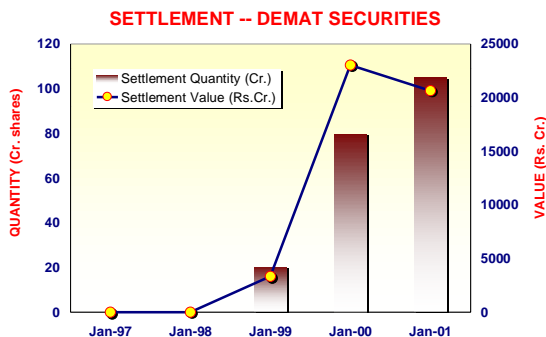
Besides, 3736 clearing member accounts have been opened to facilitate trading and settlement of demat shares in the stock exchanges connected to NSDL.

As on January 31, 2001, 3,107 cr. shares having a value of Rs. 4,19,717 cr. were dematerialised.



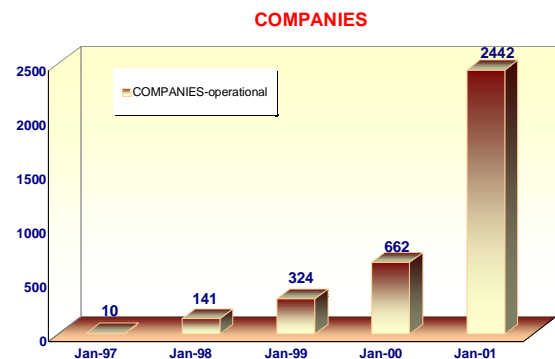

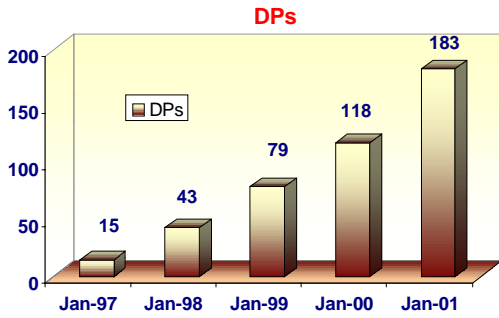
In January 2001, a total quantity of 105 cr. shares having a value of Rs. 20,636 cr. were settled in demat form in the stock exchanges connected to NSDL.

As on January 31, 2001, demat facilities are available for 2,442 companies.



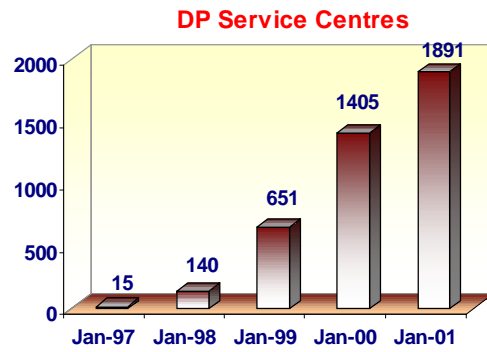

## Topic of Interest

### FAQ on Nomination

NSDL has amended its Bye Laws and Business Rules to give effect to nomination. To help answer the frequently asked questions, such questions and answers thereof are compiled and given below:

*Who can nominate?*

Nomination can be made only by individuals holding beneficiary accounts on their own behalf either singly or jointly. Non-individuals including society, trust, body corporate, partnership firm, karta of Hindu Undivided Family, holder of power of attorney cannot nominate.

*Can joint holders nominate?*

Yes. Nomination is permitted for accounts with joint holders. But, in case of death of any of the joint holder, the securities will be transmitted to the surviving holder(s). Only in the event of death of all the joint holders, the securities will be transmitted to the nominee.

*Can a NRI nominate?*

Yes, NRI can nominate directly. But, the power of attorney holder cannot nominate on behalf of NRI.

*Can a minor nominate?*

No, a minor cannot nominate either directly or through its guardian.

*Who can be a nominee?*

Only an individual can be a nominee. A nominee shall not be a society, trust, body corporate, partnership firm, karta of Hindu Undivided Family or a power of attorney holder.

*Can there be more than one nominee?*

No, at present only one nomination can be made for one depository account.

*Can a minor be a nominee?*

Yes, a minor can be a nominee. In such a case, the guardian will sign on behalf of the nominee and in addition to the name and photograph of the nominee, the name, address and the photograph of the guardian must be given.

*Can separate nomination be made for each security held in a depository account?*

No. Separate nomination cannot be made for each security. Nomination can be made account wise and not security wise.

*Can a NRI be a nominee?*

Yes, NRI can be a nominee subject to the exchange control regulations in force from time to time.

*What is the procedure for nomination?*

The procedure is simple. The nomination form duly filled-in should be submitted to the DP either at the time of account opening or later. The account holder, nominee and two witnesses must sign this form and the name, address and photograph of the nominee must be submitted.

*Can the nominee be changed?*

Yes, the nomination can be changed anytime by the account holder by simply filling up the nomination form once again and submitting it to the DP. The account holder, nominee and two witnesses must sign this form and the name, address and photograph of the nominee must be submitted. In case of joint holders, all joint holders must sign.

*What is the procedure for transmission to nominee in case of the death of the account holder?*

In case of the death of the sole holder or all the joint holders, the nominee must submit a duly filled-in transmission form and give the notarised copy of death certificate and an affidavit in the prescribed format. After verifying these documents, the DP will transmit the securities to the account of the nominee.
