Special Offer for SPEED subscription received till March 15, 2001

NSDL had launched its SPEED service in February 2000 for providing securities balances and transaction details on the Internet for Clearing Members. The scope of SPEED service is being enhanced since beginning, starting from only one update a day, to now multiple updates in a day. SPEED provides the following facilities:

- *Holding Statement and Transaction Statement* : SPEED enables the Clearing Member to view its holding and transaction statement for its pool account. It can view the securities received by it into its pool account from its Clients for the purpose of pay-in. It can also view its instructions which are in Overdue status viz; awaiting delivery of securities from clients. On that basis, the Clearing Member can follow-up with its Clients for shortages in deliveries. It can also view the securities received into its pool account from the Clearing Corporation on pay-out.
- *Transaction File Download* : SPEED provides file download facility so the clearing member can import the transaction data into its back-office system for further use.
- *ISIN Master Download* : SPEED enables the clearing members to update its back-office system with the details of ISINs in the NSDL system by using the ISIN Master download facility.

After March 15, 2001, the subscription/renewal rate will be Rs. 4000 for a normal pool account. In case the Clearing Member has a Vyaj Badla/ALBM pool account and if it intends to subscribe for access to both the normal pool account and Vyaj Badla/ALBM pool account, then the charge will be Rs. 6000. However, if Clearing Members subscribe/renew their subscription before March 15, 2001, the charge for normal pool account will be Rs. 3000 and for normal pool account plus Vyaj badla/ALBM pool account will be Rs. 4500/-.

NSDL's website provides file download facility for addresses where certificates/Demat Request Forms have to be sent for demat.

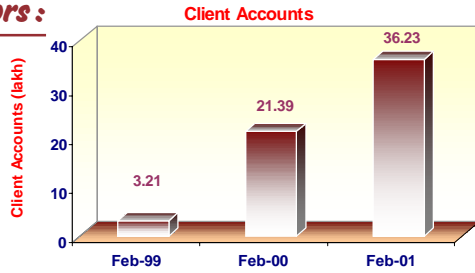

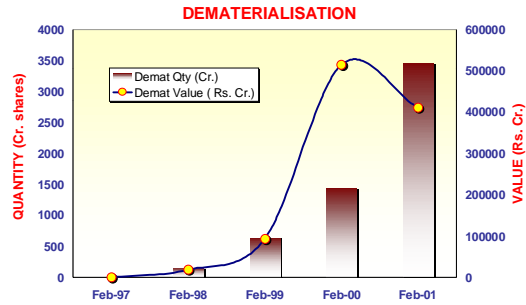


As on February 24, 2001, 36,23,671 Investor accounts have been opened from within the country and abroad.

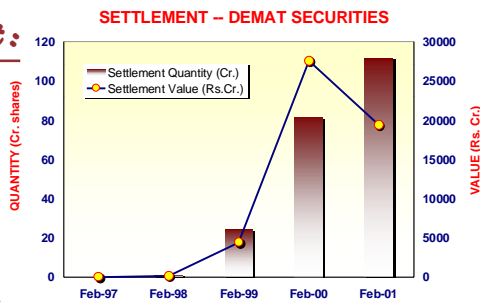
Besides, 3782 clearing member accounts have been opened to facilitate trading and settlement of demat shares in the stock exchanges connected to NSDL.

As on February 28, 2001, 3,461 cr. shares having a value of Rs. 4,11,015 cr. were dematerialised.



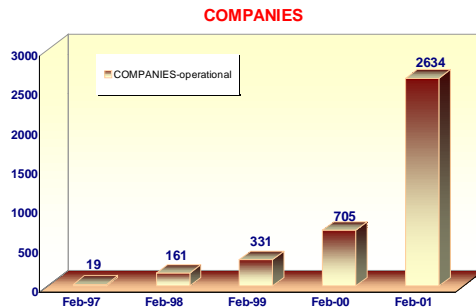

In February 2001, a total quantity of 112 cr. shares having a value of Rs. 19,389 cr. were settled in demat form in the stock exchanges connected to NSDL.

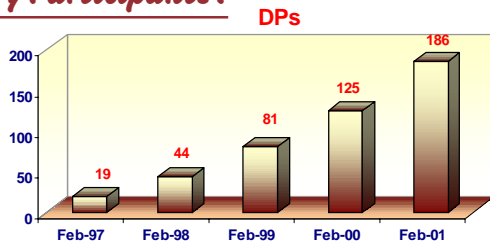

As on February 28, 2001, demat facilities are available for 2,634 companies.



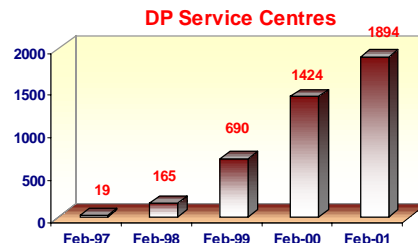

Topic of Interest

Care to be taken by investors to receive corporate benefits

Corporate Benefits arising to investors may be either cash benefits like dividend, interest, etc. or non-cash benefits like bonus, rights, etc. The Issuer announces a record date/book closure for the purpose of determining the entitlement of corporate benefits. NSDL provides information of beneficial ownership details as of the record date/book closure to the Issuer. Based on this information provided by NSDL, the Issuer distributes the corporate benefits to the investors.

In view of the forthcoming book closure season, beneficial owners (depository account holder) may take the following care:

- Ensure that all securities purchased are received into beneficiary account before the record date/book closure. The securities must not be lying in the pool account of the broker. Now, SEBI has made it mandatory for Clearing Members to move securities to the beneficiary account of the investor within **six calendar days** after pay-out day. With effect from April 2, 2001, the time limit will be further reduced to **four calendar days** or **two working days**, whichever is later.

- If the securities are lying in the pool account, company may give the corporate benefits to the broker. Therefore, investor may collect benefits from its broker.
- If the investor wants any change in the bank particulars from the one given in the account opening form, it must be changed before the record date/book closure. The bank particulars of the investor will be printed on the dividend/interest warrant.
- Ensure that MICR number (as can be seen on the cheque book)is registered by the DP in the depository system.
- In case the investor intends to avail of ECS facility for receiving dividend/interest, the investor must write directly to the Issuer/R&T Agent.
- If the investor has securities in its beneficiary account as on the record date/book closure, then non-cash benefits like bonus/rights, etc. will be received directly in that account.
- If the investor has physical securities, it can still receive the corporate benefits in demat form by writing directly to the Issuer/R&T Agent giving its DP Id, Client Id & Client Name.
