No voting rights for shares held in pool account

SEBI has clarified vide its letter no. SMDRP/NSDL/36563/2001 dated April 10, 2001 that clearing members, clearing corporations and intermediaries cannot have voting rights in respect of securities held in pool account. SEBI had earlier, vide its Press Release No. PR 114 / 2000 dated May 23, 2000, notified permission to distribute bonus and dividend to the Clearing Members in respect of the balances lying in the CM Pool accounts as of the record date / book closure. The Clearing Members will be responsible for distribution of these corporate benefits to their clients.

NSDL plans to conduct Quality Improvement programmes across the country

NSDL plans to conduct 29 Quality Improvement Programmes in 28 cities/towns across the country between May 1, 2001 to September 30, 2001. The programmes are being organised to help DPs in achieving the objective of having at least one employee qualified in the NSDL -Depository Operations Module, in each of its branches. To facilitate more and more candidates to attempt this NCFM test, NSDL in conjunction with NSE, plans to conduct the NCFM examinations at all the 28 cities/towns one week after the training programme is conducted at that location. The details of the training programmes for the months of May and June are published on the last page of this Nest Update.

142 scrips to be traded only on "trade for trade" segment as they have not established connectivity with both the depositories

SEBI has notified vide its press release SMDRP/POLICY/CIR-27/2001 dated April 16, 2001 that 142 scrips can be traded only on "trade for trade" segment as they have not established connectivity with both the depositories. With this, the total number of scrips to be traded only on "trade for trade" segment has gone up to 636.
