From the Chairman & Managing Director's Desk

Dear Reader,

NSDL has completed ten years of operations. The progress that NSDL could achieve in these ten years can be summed-up by way of some key statistics. Till October 31, 2006, 18,884 crore securities worth more than Rs 28,67,500 crore have been dematerialised. More than 6,300 companies have joined NSDL and 233 DPs service about 77 lakh investors through more than 3,200 locations across the country. Today, equity markets settle almost 100% of its volumes in the dematerialised form.

We.f. April 1, 2006 PAN card is mandatory for opening a demat account. The existing demat account holders are required to provide the PAN card to their Depository Participants by December 31, 2006, as per the SEBI directive. Although a lot of investors have complied with this requirement, still many investors are yet to comply. I urge such investors to comply with the guidelines in order to avoid the inconvenience of their account becoming inoperative after the deadline.

Our internet based initiatives viz., *SPEED-e* and *IDeAS* are gaining steady popularity and I am sure that with the increase in number of internet users across the country, these initiatives will find many more active users in days to come. Today, 67 DPs (last year 58) are offering *SPEED-e* facility and 124 DPs (last year 111) are offering *IDeAS* facility. A list of the DPs offering *SPEED-e* and *IDeAS* is given in this issue. *IDeAS* earlier enabled Clients (Beneficial owners) to view the latest balances and transactions that have taken place in the last five days, in their depository accounts. However, from October 2006 NSDL has provided a facility whereby Clients can view the transactions for a period of past 30 days. Clients can now select a period upto 30 days from the current date, to view the transactions. NSDL also introduced a facility of download of digitally signed monthly transaction statements through *IDeAS*. These month-wise transaction statements are maintained for a period of 12 months on *IDeAS*.

NSDL Database Management Limited (a wholly-owned subsidiary of NSDL) has set up National Skills Registry (NSR) in association with NASSCOM. NASSCOM, an association of IT and ITES companies in India, had approached NSDL to set up a NSR containing personal, academic and career information of IT professionals (ITP) and to issue them an identity number and a card. The details include finger-prints, photograph and signatures of the ITP. The data submitted by the ITP can be checked by an Empanelled Background Checker (EBC). The results of the background check can be viewed by any prospective employer, authorized by ITP. The background checking procedure will help prevent wrong claims by ITPs. In January 2006, H'ble Union Minister of Communication & Information Technology, Shri Dayanidhi Maran formally inaugurated NSR.

NSDL has always ascribed prime importance to Information Security in its operations. From time to time NSDL has initiated and implemented various measures for enhancement and re-assurance of the Information Security. To benchmark the practices and procedures adopted by NSDL against the global standards, NSDL has got its systems certified for ISO 27001 standards in October 2006. ISO 27001 standards are published by International Organisation of Standards to provide a model for setting up and managing an effective Information Security Management System (ISMS). ISO 27001 standards facilitate adoption of a process approach towards maintaining and measuring the effectiveness of an implemented ISMS, facilitating continuous improvement.

In keeping with its practice of reaching out to the investors to get their feedback and understand their problems, NSDL organized 137 investor depository meets and interacted with about 13,500 investors across the country during the last year. In addition to NSDL's practice of holding such seminars, NSDL has released advertisements on various television channels in nine languages. NSDL has also continued its practice of testing the readiness of its disaster recovery site (DRS) and is satisfied with its functioning. A detailed write-up on NSDL initiatives is given in this issue.

This NEST Update, the 10th anniversary edition, gives details of the progress of NSDL. This progress would not have been possible but for the market acceptance of our services. We are thankful to all those who stood by us and helped us reach this far.

I look forward to your continued support and cooperation.

News

Subscription to *IDeAS*

The following Depository Participant (DP) has subscribed to the *IDeAS* facility of NSDL in the month of October 2006:

- State Bank Of Bikaner & Jaipur

This takes the total number of DPs who have subscribed to *IDeAS* to 124. This is inclusive of 67 DPs who have subscribed to SPEED-e.

Eastern Financiers Limited joins NSDL as DP

Eastern Financiers Limited has been made operational as a DP on October 20, 2006. It will conduct its depository operations from Kolkata. The DP Id allotted is IN303181.

This takes the total number of operational DPs to 233 and the total number of operational DPM set-ups to 309.

Closure of Apeejay Securities Private Limited DP Operations

Apeejay Securities Private Limited (ASPL) (DP Id IN302308), a Depository Participant of NSDL has informed NSDL that it intends to close down its depository operations.

Clients of ASPL are requested to get their securities transferred to the account opened with any other DP or get them rematerialized.

New feature in *IDeAS* - viewing of transactions

NSDL offers an internet based facility called *IDeAS (Internet-based Demat Account Statement)* through <https://speed-e.nsdl.com>. *IDeAS* at present enables Clients (**Beneficial owners**) to view the latest balances and transactions that have taken place in the last five days, in their depository accounts. Clients will now be able to view the transactions for a period of past **30 days**. Clients can select the period upto 30 days from the current date, to view the transactions.

IDeAS also features the facility of download of digitally signed monthly transaction statements for a period of 12 months.

This has been informed to DPs vide Circular No. NSDL/POLICY/2006/0045 dated October 5, 2006.

Training Programme for Compliance Officers of DPs

NSDL conducted a training programme in Mumbai for compliance officers of DPs. Areas covered during the training programmes were compliance requirements, inspection and internal audit. The programme was conducted in Mumbai on November 3, 2006, which was attended by 30 persons of 21 DPs.

SEBI circular providing clarification on Permanent Account Number (PAN) for NRIs/ PIOs / foreign nationals

SEBI has vide its circular no. MRD/DoP/Dep/SE/Cir-17/06 dated October 27, 2006 issued certain clarifications on PAN for Non-Resident Indians (NRIs)/ Persons of Indian Origin (PIOs)/ foreign nationals, extracts of which are as under:

1. This has reference to SEBI Circulars No. MRD/DoP/Dep/Cir-09/06 dated July 20, 2006 and MRD/DoP/Dep/SE/Cir-13/06 dated September 26, 2006 offering clarifications pertaining to complying with the mandatory requirement of PAN for operating Beneficiary Owner (BO) Account as well as trading in the cash market.
2. Pursuant to the representations received from Non-Resident Indians (NRIs)/Persons of Indian Origin (PIOs), SEBI vide para No.4.3 of the circular dated July 20, 2006 enabled such NRIs/PIOs who are not able to obtain PAN for one reason or the other but are holding securities in physical form and desire to sell the same, to open a "limited purpose BO account" without PAN, subject to certain conditions specified therein. The same was also extended for trading in cash market for such NRIs/PIOs vide circular dated September 26, 2006. Further, SEBI had also taken up the matter with CBDT vide letter dated July 31, 2006 requesting CBDT to address the concerns of NRIs in this regard.
3. The Directorate of Income Tax (Systems) vide PAN Circular No. 4 dated October 11, 2006 has now issued guidelines to its service providers (M/s UTITSL & NSDL) facilitating the citizens of India residing outside India, foreign citizens and

other persons (like companies,/trusts/firms) having no office of their own in India to obtain PAN based on the copy of their passport as ID proof and copy of passport/copy of bank account in the country of residence as address proof. A copy of the said circular is enclosed as Annexure-I for ready reference.

- In the light of the above and since NRIs/PIOs/foreign nationals have now been enabled by the Income Tax Department to obtain PAN as stated above, it has been decided to withdraw the facility of opening a "limited purpose BO account"/ trading account by them without PAN. However, the NRIs/PIOs who have already opened such BO accounts/trading accounts without PAN shall be required to comply with the mandatory requirement of PAN on or before December 31, 2006, failing which such accounts shall be made inoperable by the Depository/Depository Participant/Broker."

This has been informed to DPs vide Circular No. NSDL/POLICY/2006/0054 dated October 27, 2006.

As on October 31, 2006, there are 76,95,961 Investor accounts from within the country and abroad. 2,125 clearing member accounts have been opened to facilitate trading and settlement of demat shares in the stock exchanges connected to NSDL. As on October 31, 2006, 233 Depository Participants are offering depository services. DP services are provided from 3,212 locations across the length and breadth of the country.

NSDL Initiatives

During last 12 months (i.e. November 2005 to October 2006), the following initiatives were taken by NSDL with an objective of spreading awareness about the depository system, its benefits and safety features and new facilities introduced, amongst all its users:

Towards Investor Awareness:

- **Investor Depository Meets (IDMs)** - Investors throughout the country were approached through a series of 'Investor Depository Meets'. These programs were organised to spread awareness amongst the accountholders and others about the new facilities introduced by NSDL, the safety features and precautions to be taken by accountholders while operating in the depository environment.
- **Depository Promotion Programs (DPPs)** - In order to spread awareness about depository and to encourage those shareholders who are still holding shares in physical form to dematerialise their shares, NSDL conducted depository promotion programs (DPPs).

During last 12 months, 127 IDMs and 10 DPPs were organised across the country, which were attended by about 13,500 persons. The zone-wise details of these seminars organised during the period are given below:

- **Advertisement Campaign** - NSDL has been conducting nationwide advertisement campaigns since 2001. This year, the campaign, conducted in February 2006, spanned across 29 publications (13 leading national dailies and 16 vernacular dailies) in 10 languages with an estimated circulation of about 2.22 crore. NSDL also carried out advertisement campaigns in April 2006 and August 2006 regarding SEBI directive on PAN. The PAN card related campaigns spanned across 34 publications (16 leading national dailies and 18 vernacular dailies) in 11 languages with an estimated circulation of about 2.38 crore.
- **Investor's Guide** - NSDL publishes an "Investor's guide to the Depository System" for promoting investor's understanding of the system. This guide attempts to answer frequently asked questions raised by the investors in relation to depository operations. Apart from English and Hindi, this guide is also available in other regional languages. Investors may obtain a copy of this publication free of cost from NSDL, Mumbai and its branches at New Delhi, Kolkata and Chennai.
- **Posters and leaflets on PAN card requirement** - Posters on requirement of PAN card were distributed to all branches of Depository Participants and main offices of NSE & BSE Brokers for displaying the same at prominent locations in their offices. Leaflets on PAN card requirement have been printed in 10 languages and are distributed to investors during Investor Depository Meets.
- **NSDL Website** - The NSDL website hosts exhaustive and updated information for investors, companies and DPs. In January 2006, NSDL revamped its website for repositioning the data links and to carry-out a well-defined and consistent navigational architecture to ensure easy retrieval of information for the visitors to the site and help them reach their desired page with minimum number of clicks. Details available on the website include list of securities available for demat, DP locations and contact details, dates & venues of forthcoming IDMs, various search options, important circulars and Bye Laws & Business Rules of NSDL. The website also facilitates registration of grievance and displays list of companies with poor demat confirmation record.

- **TV Advertisements** - Apart from the investor awareness programmes mentioned above, NSDL is carrying-out nationwide investor awareness programme by way of advertisements on various Television channels in English, Hindi and other regional languages. Advertisements are carried out in nine languages viz., English, Hindi, Gujarati, Marathi, Tamil, Malayalam, Kannada, Telugu and Bengali.

These advertisements are aired from November 2006 over a period of about three months.

Towards education of Business Partners etc :

- **Seminars on Anti Money Laundering law:** In order to educate DPs about the guidelines of Anti Money Laundering law, a series of seminars on were organized as under:

Seminars in Kolkata, Hyderabad and Chennai are organized by Association of NSE Members of India (ANMI) in association with NSDL. Mr. Pradeep Goel, Assistant Director, Financial Intelligence Unit (FIU) - India addressed the participants. About 250 representatives of DPs attended these seminars.

- **Training Programme for Compliance Officers of DPs:** NSDL conducted training programmes for compliance officers of DPs. Areas covered during the training programmes were compliance requirements, inspection and internal audit. The programmes were conducted at Mumbai (September 29, 2006 and November 3, 2006), New Delhi (October 5, 2006), Kolkata (October 10, 2006) and Chennai (October 13, 2006). 230 representatives from 169 DPs participated in these programmes.
- **Training Programme for internal auditors of the DPs:** During September 2006, NSDL conducted training programmes for internal auditors of the DPs. Areas covered during these programmes were Account Opening, Dematerialisation / Rematerialisation, Settlement, Pledge and Hypothecation, Corporate Actions, Back office operations, critical aspects of Depository Participant Operations, Guidelines on internal audit, Compliance, Depository Participant Inspection; findings and perspectives, Anti Money Laundering Requirement and Systems overview. 176 representatives from various audit firms participated in these programmes.
- **Training programmes for business partners:** NSDL periodically conducts three-day training programmes for DPs and two-day training programmes for Issuers / R & T Agents. Details of such programmes conducted from November 2005 to October 2006 are as follows:

Existing Demat account holders would not be able to operate the accounts if they do not produce the PAN Card or do not resolve discrepancies, if any, in the PAN details by **December 31, 2006**. Such accounts would be 'Suspended for Debit' until PAN details are verified and updated by the Depository Participant (DP).

In case of Demat accounts held jointly, all account holders need to provide their PAN Cards.

Original PAN Card needs to be produced to the DP for verifying the photocopy.
