From the Managing Director's Desk

Dear Reader,

In the last four years India's capital markets have completed the transformation to paperless settlement to the extent of 99.5%. This level of settlement in demat form could not have been imagined in so short a period of time when NSDL started its operations. Till date over 2500 crore securities worth more than Rs.3,25,000 crore have been dematerialised. More than 1800 companies have joined NSDL and more than 160 DPs service 32 lakh investor accounts across the length and breadth of the country. The speed of acceptance of demat by the investors, retail as well as institutional and the market intermediaries has been dramatic. In line with our commitment to provide safe, efficient and cost effective services, we reduced the transaction charges further, this year.

The Finance Act, 2000 has paved the way for transactions in debt instruments in demat form by exempting debt instruments from stamp duty on transfer in a depository. The list of debt securities that are available for demat is given in the pages that follow. We have no doubt that the next one year will witness the demat of debt securities on a large scale by investors accompanied by a more liquid debt market. The Reserve Bank of India is encouraging investors in Commercial Papers and Government Securities to deal in demat form. We hope that the coming year will see the availability of Government Securities to retail investors thereby making it possible for ordinary investors to access safe investments.

In the coming year we will consolidate our position, improve process efficiencies and add new features to the Depository operations. It will be our endeavour to enable the DPs to service investors with more up to date information even at their branch offices. NSDL also hopes to reach out to investors by making it possible for DPs to provide internet based services. Brokers are already availing of NSDL's internet facility to 'view' their settlement accounts.

This NEST Update, the fourth annual edition, gives details of progress of NSDL since the last edition. This progress would not have been possible but for the tremendous market acceptance of our services and regulatory support at critical junctures. We are thankful to all those who stood by us and helped us reach this far.

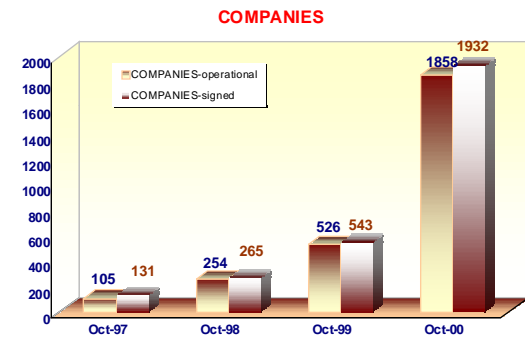

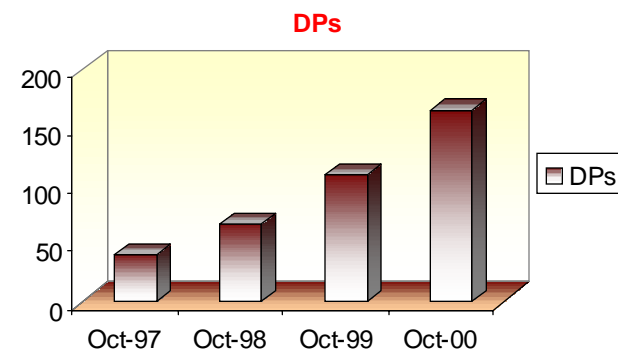
Companies:



As on October 31, 2000, 1932 companies have signed agreements with NSDL. Out of these, demat facilities are available for 1858 companies

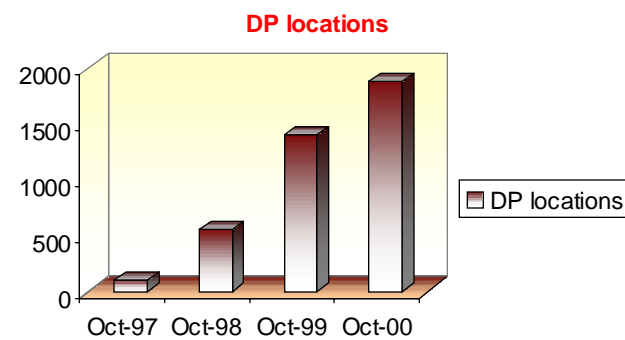
Depository Participants

As on October 31, 2000, DP services are provided from more than 1800 locations across the length and breadth of the country.

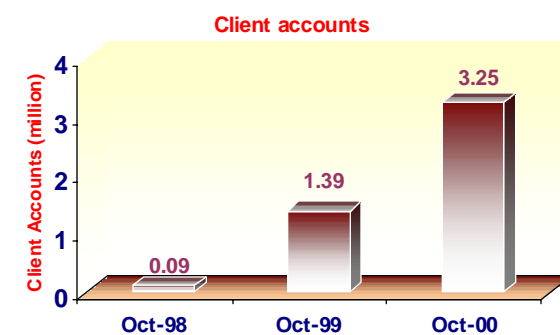
DP locations



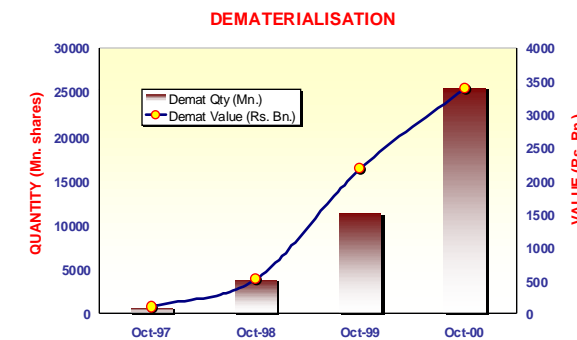
Investors

Besides these, more than 3580 clearing member accounts have been opened to facilitate trading and settlement of demat shares in the stock exchanges connected to NSDL.



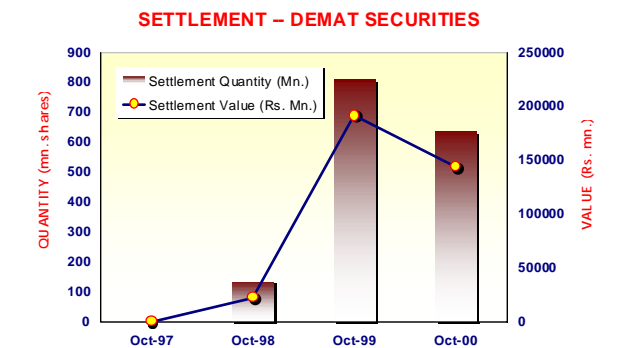
Dematerialisation

Marketing Initiatives

Over the years we have tuned our marketing initiatives to reflect the changing scenarios and needs in the market. In keeping with the same, the following new initiatives were undertaken by NSDL during the last year:

Investor Depository Meets: Since November 1999, 49 Investor Depository Meets (IDMs) were conducted attended by 11520 persons.

Investor Depository Meets in smaller locations: After the SEBI mandate making it compulsory for all categories of investors to settle their trades in demat form it was felt that the depository culture was permeating to smaller cities & towns at a fast pace. Hence, a need was felt to organise IDMs in smaller cities and towns also. IDMs were conducted at 16 small towns like Dehradun, Nadiad, Salem, Madurai, Aurangabad, Nasik, Nellore, Guntur, Gwalior, Mysore, Sangli, Satara, Jamshedpur, Rourkela and Kakinada. About 2230 persons attended these Meets. Presentations were made in local languages to the extent possible.

Brochure on Demat Simplified: NSDL initiatives, market acceptance and regulatory intervention at critical junctures moved the securities settlement process to the depository. Investor participation in the depository grew significantly. In this scenario, it was felt that it is imperative that each investor who is a participant in the NSDL depository process is made aware of his rights and responsibilities in respect of the various depository activities. A four page brochure titled "Demat Simplified" was thus prepared & distributed to the investors.

Procedural Training program via teleconferencing facilities: The procedural training program for DPs was conducted by using teleconferencing facilities established by IGNOU. It was telecasted at 13 centres whereat around 250 people attended.

Publications: A variety of publications were developed and published to educate and update the various segments of users:

- Investors' guide to depositories
- Clearing member's guide
- DP Directory
- Nest Update
- Demat Simplified

NSDL film on CD-rom: NSDL film for retail investors in English, retail film in Hindi and a film for institutional investors was developed on the CD-rom. A copy was given free of cost to the DPs on request to educate their investors.

DP Conference: NSDL organises DP conference once in six months to interact with the DP managements. These conferences are targeted to sensitise the top managements of these organisations towards issues related to servicing investors, resource allocations, expansion of branch network, etc. for depository services. These conferences also provided a platform to the DPs to collectively give their feedback on the NSDL system.

Certification Programme

NSDL launched a Quality Improvement Program in depository operations from 1.5.1999 for the staff of DPs. NSDL has made it mandatory for a DP to have at least one employee who has successfully completed the Certification Program at each of its service centre. This rule comes into force w.e.f. 1.1.2001.

To facilitate staff of the DPs and the others to successfully participate in the certification program, NSDL has been organising Quality Improvement program which includes the training program and a test at all locations where there are more than 10 DP service centres. Quality Improvement Program was conducted at Mumbai, New Delhi, Goa, Ahmedabad, Hyderabad, Cochin, Coimbatore, Ludhiana, Rajkot, Chennai, Agra, Bangalore and Jaipur for the benefit of 360 persons.

Till date 2521 people attempted these tests, out of which 873 have successfully completed the certification program.

Corporate Actions

Direct Credit of Shares

NSDL offers the facility of directly crediting investor accounts with securities arising out of corporate actions like Bonus issue, Capital restructuring, amalgamation, demerger, subdivision. This facility also include crediting of shares on allotment in a public or rights issue.

A total of 637.19 crore equity shares have been credited to 16.29 lakh beneficiary accounts in the above-mentioned corporate actions through NSDL. This facility has helped avoiding printing of 6.37 crore share certificates (assuming a market lot of 100). In addition, companies benefited by savings in cost and effort involved in handling the certificates, postage, administrative costs and other incidental expenses.

Direct credits to beneficiaries through NSDL depository system eliminates the risk of loss of securities in transit or fraudulent interception of the same. This has also resulted in reduction in the number of investor grievances pertaining to non-receipt of corporate benefits.

Dividend Distribution Service

NSDL has recently undertaken dividend distribution directly to shareholders holding shares in demat form. This activity has been carried out for eight companies viz. BSES Ltd., Essel Packaging Ltd., Western Hatcheries Ltd., Satyam Computer Services Ltd., Global Telesystems Ltd., Hindalco Industries Ltd., Zee Telefilms Ltd. and VSNL. A total of Rs.96.24 crore has been distributed to 3,14,657 shareholders constituting more than 87% of the dividend payable on the shares of these companies held in demat form.

Demat of Debt Instrument**Debentures & Bonds**

The Finance Act 2000, has paved the way for transactions in debt instruments in demat form by exempting debt instruments from stamp duty on transfer in a depository.

Since then, more than 26 corporates have joined NSDL to make available 235 debt instruments for dematerialisation. Some of the major Issuers of Debt Instruments like ICICI Limited, IDBI, HDFC, Larsen & Toubro, Hindalco Limited, Indo Gulf Corporation, Reliance Industries Limited, Reliance Petroleum Limited, Ford India Limited, Rural Electrification Corporation Limited, etc., are now offering this option to their bond holders (debenture holders).

This has given a choice to investors to hold the debt instruments in demat form. Holding debt instruments in demat form gives following benefits to the Investors:

- Savings in stamp duty payable on transfers ;
- Electronic settlement of trades across the country ;
- Flexibility in denomination of the securities ;
- All investments get summarised in a single Statement of holding ; &
- All the benefits of dealing in demat form.

Keeping in view the benefits of Demat, some issuers are making allotment against fresh issues of debt instruments is being given directly in Demat form. Maruti Udyog Ltd., National Highway Authority of India, Grasim Industries Ltd. and Orix Auto Finance Ltd. are few examples.

Commercial Paper

RBI in its recent Mid-term Credit & Monetary Policy dated 10th October 2000 has come out with revised guidelines for issue of Commercial Paper. This policy encourages Banks, FIs, PDs and SDs to invest in Commercial Paper only in demat form.

Government Securities

A new investment opportunity is made available to investors by two Primary Dealers viz. PNB Gilts Limited and IDBI Capital Market Services Limited. They have taken lead in retailing of Government securities in demat form. Investors can buy government securities even in lots of Rs. 25,000/- in demat form.

Training of Business Partners

Depository operations is essentially a special skill industry and delivery of service to investor requires thorough knowledge of system, application, legal and operational aspects. Therefore, NSDL conducts training programs for its business partners viz. Depository Participants, Issuing Companies/R & T Agents, Clearing House/Clearing Corporation of the stock exchanges that have joined NSDL. Training programs are conducted on monthly basis for all business partners viz. DP, Issuers who have signed tripartite agreement with NSDL, R & T Agents connected to NSDL. These programs include theoretical as well as hands on sessions. About 900 participants from various business partners have been trained during the last one year. Business partners may contact Training Division of NSDL for obtaining more details. NSDL has also taken initiative to conduct special training programs for the Internal Auditors of the business partners.

Corporate Benefits for Shares bought but Lying in Pool Account of Broker

An investor is entitled for corporate benefits like dividends, bonus, rights etc. only if the holdings are in its beneficiary account on the record date. Brokers are required to transfer the shares purchased by investors to investor's account after they receive purchase consideration within working days. Investors should insist upon transfer of shares purchased by them to their beneficiary owner's account immediately after payment is made. Otherwise, even though shares were purchased for the buyer, but held back in the pool account of the broker, the buying investor will not be entitled to the corporate benefits like dividends, bonus shares, rights shares etc. Under the SEBI Rules, a broker is required to deliver shares to the buyer or make payments to the seller within 2 working days from the time of pay out (both for securities and funds) declared by stock exchange. NSDL has set up a procedure to recommend to the company for release of corporate benefits to the buyers whose shares are lying in the CM pool account. However, investors should insist and ensure that the shares bought by them are received into their account well in advance of the record dates.

The Road Ahead

Most of the actively traded companies have already joined the NSDL depository. Bringing in debt instruments and government securities into the NSDL depository will be the focus area in times to come. NSDL will endeavor to offer a facility to the investor to hold their investments in all types of securities in demat form.

DP services are being offered from more than 1800 locations across the country. It is expected that DP services will penetrate further into more locations near the investors.

In order to enhance quality of service to the investors, NSDL will take initiative to provide Investor specific Internet based service. First of such services will be launched in the first quarter of year 2001.

A new initiative based on permission granted by Government of India for connecting two wide area networks (WAN to WAN) will be launched soon. This facility, if availed by DPs, will help branches of DPs to connect to main DP machine and provide more upto date to investors.

To improve service standards, DPs will be required to employ atleast one qualified person at each of their branches. To facilitate DPs to have their staff qualified, efforts will be intensified to conduct 'Procedure Training Programs' and 'NSDL Depository Operations Module' tests at the locations where DPs are located. The investor education initiative will continue and NSDL would organize these programs at smaller cities and towns.

Appeal to the Investors

SEBI directive on Account Opening

The Securities and Exchange Board of India has issued guidelines for the due diligence needed for opening of depository account.

- A beneficiary account must be opened only after obtaining a proof of identity of the applicant. The applicant's signature and photograph must be authenticated by an existing account holder or by the applicant's bank or after due verification made with the original of the applicant's valid passport, voter ID, driving license or PAN card with photograph
- the account opening form should be supported with proof of address such as verified copies of ration card / passport / voter ID / PAN card / driving license / bank passbook. An authorised official of the Participant, under his signature, shall verify the original documents.

SEBI has also directed all Participants to immediately verify the accounts of all the beneficiary owners who have opened accounts with them and confirm in writing to NSDL, that Participants have fully complied with the abovementioned procedure in all the cases. Failure to produce the original documents within the prescribed time would invite appropriate action against such account holders, which could even include freezing of their accounts. Investors are requested to co-operate with Depository Participants in completing this exercise.
