1 CLIENT MASTER CREATION UPLOAD

1.1 OVERVIEW

The upload facilitates DPs and CCs to upload Client details generated in their back-offices into the DPM system. The process is achieved through the use of following flat-files

- PRI file containing the primary information of the Client.
- ADD file containing the address information of the Client.
- ATH file containing the authorized signatory details.
- POA file containing the authorized signatory details.
- SGN files containing the signature details.
- FTXT file containing the Reference & description details.

While uploading the files, the DP or CC needs to take care of the following salient features:

The .PRI, .ADD .ATH & .POA files must all be present at the time of the upload. The .SGN files must be present if the signature information is given in the .PRI file. The .SGN files are expected in TIFF 4 format. The FTXT file must be present if Reference & description details client is provided.

In the record Header, the Batch number and Branch Code combination must be unique. All the files should have the same Batch Number, Branch code and DP ID. The Business Partner (BP) Role is expected to be '01' always. The total number of records must correspond to the total number of detail records. Further, after the file is uploaded, the DPM system will generate response file, if no error is found. Otherwise, the DPM system would generate .err file in case of error in the file uploaded.

1.2 INSTRUCTIONS

1. There should not be repetition of line number.

2. For a particular Client there should be only one record for primary and address details, and but there can be multiple records for authorized signatory details and POA details.

3. In creation all files are mandatory (.pri , .ath , .Poa , .Add and .sgn) file should be present if the signature length file is specified in the .pri file. The size of each .sgn file should not exceed 64 K. Zip file containing those files should be uploaded to the system. The FTXT file must be present if Reference & description details client is provided.

4. Multiple occurrences of any file except signature file are not allowed.

5. Any file other than the mentioned files are not allowed.

6. The uploaded zip file should not contain any other folder.
