Participants are requested to carry out necessary changes to the back office systems with respect to the above file formats as well as file formats mentioned in Circular No. NSDL/POLICY/2010/0001 dated January 1, 2010 and NSDL/POLICY/2010/0023 dated March 8, 2010 by **May 5, 2010**. Participants are requested to note that these changes should be applied to the back-office system only upon further advice of NSDL.
