 12A of Weapons of Mass destruction and their Delivery Systems (Prohibition of Unlawful
 Activities) Act, 2005.

Participants should scan all existing accounts to ensure that no account is held by or linked to any of the entities or individuals included in the list and also ascertain the same for future accounts as well (as per SEBI Circular 'Procedure for implementation of Section 12A of the Weapons of Mass Destruction and their Delivery Systems (Prohibition of Unlawful Activities) Act, 2005 Directions to stock exchanges and registered intermediaries' dated April 26, 2023).
