Principle 15 - General Business Risk:

An FMI should identify, monitor, and manage its general business risk and hold sufficient liquid net assets funded by equity to cover potential general business losses so that it can continue operations and services as a going concern if those losses materialize. Further, liquid net assets should always be sufficient to ensure a recovery or orderly wind-down of critical operations and services.

NSDL holds adequate liquid net assets funded by equity (such as common stock, disclosed reserves, or other retained earnings) so that it can continue operations and services as a going concern if it incurs general business losses. As on September 30, 2024, NSDL's liquid net assets amount to 44 months of current operating expenses. Further, NSDL has a well-documented Wind Down Plan in place.
