## **Principles of Financial Market Infrastructures (PFMIs)**

### **Quarterly Quantitative Disclosure for quarter ended March 2024**

Pursuant to SEBI circular number SEBI/HO/MRD/MRD/MRD-PoD-3/P/CIR/2023/190 dated December 19,2023, mandating the depositories to disclose the applicable quantitative PFMI principle(s) on quarterly basis on their website. Accordingly, the quantitative disclosure with respect to PFMI principle(s) applicable to National Securities Depository Limited (NSDL) is mentioned below.

#### Principle 15 - General Business Risk:

An FMI should identify, monitor, and manage its general business risk and hold sufficient liquid net assets funded by equity to cover potential general business losses so that it can continue operations and services as a going concern if those losses materialize. Further, liquid net assets should at all times be sufficient to ensure a recovery or orderly wind-down of critical operations and services.
